**VICTIMS TOUR U.S. CITIES**

WASH. (WNS) -- "We feel we have to tell what the PLO is all about," Ankie Spitzer, whose husband was one of the 11 Israeli athletes killed at the Munich Olympic games in 1972 said at a press conference at the Israel Embassy here. Spitzer, along with two other Israelis who have been victimized directly or indirectly by the PLO over the years, are in the U.S. as part of a tour to inform the American public of PLO atrocities.

Spitzer is joined on the tour with Yossi Hochman, whose wife and two children were killed in a 1978 coastal road terrorist attack and in which he lost the lower part of his legs; and by Preeti Sylvia Arroyo, whose two children were killed in a grenade attack in January 1971 in the Gaza Strip. The three Israelis are members of the Israel-based Organization of Victims of PLO Terror.

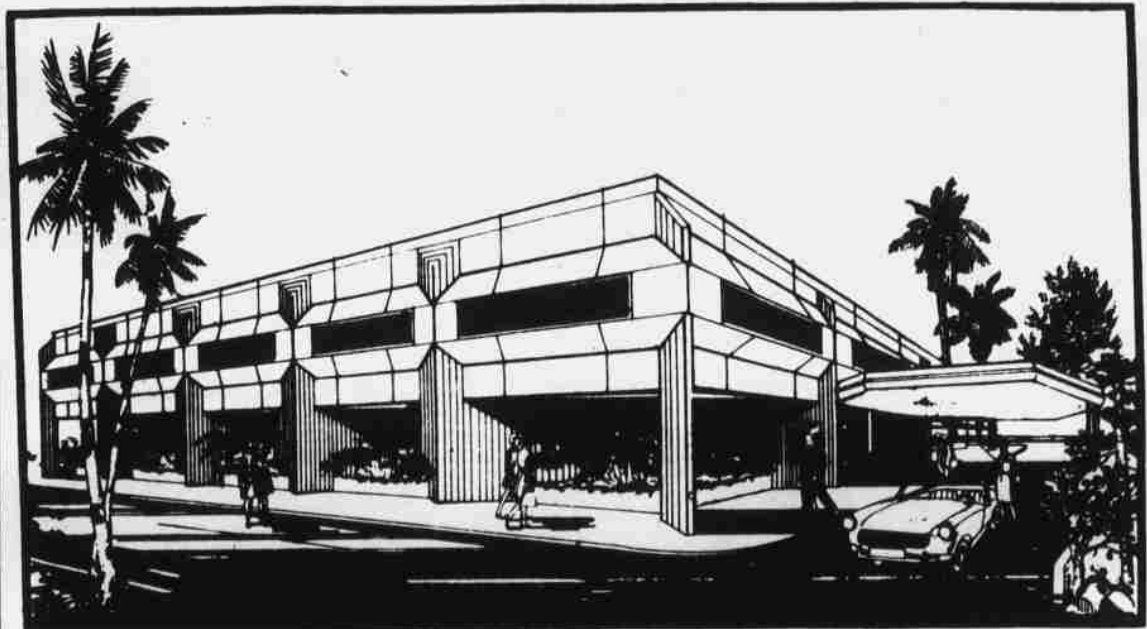
UNITED NATIONS (WNS) -- The Security Council extended the mandate of the United Nations Interim Force in Lebanon (UNIFIL) for another two months. The vote was 13 in favor with two countries -- the Soviet Union

and Poland -- abstaining. The resolution also authorizes UNIFIL to carry out humanitarian and administrative tasks assigned to it by earlier Security Council resolutions. The new mandate will expire October 19.
