majority in the voting procedure or call for a two - thirds vote.

But then the delegate of Finland saved the day. Ilkka Pastinen, speaking on behalf of the Nordic countries on a point of order, formally moved that no action be taken on the Iranian amendment and he asked for an immediate vote. But the satanic one, sensing what was up, cried out in despair, charging a conspiracy was afoot. Khomeini's man knew that his game was up. His maneuver had boomeranged.

The vote against his amendment was 75 in favor to 9 against with 31 abstentions. Let's record those few who voted with Iran: Afghanistan, Albania, Algeria, Cuba, Grenada, Libya, Nicaragua and Viet Nam.

It must be noted here that had it not been for the adamant position taken by Jeane Kirkpatrick and the U.S. Administration generally based on a strong resolution adopted by the Congress on this whole issue the picture might have been quite different at this 37th session of the Assembly. The writer has time and again stressed the strong links which bind America and Israel, that the two nations, despite passing differences, are destined to work together as close allies.

A ray of light beamed on the Assembly as Ambassador Yehuda Z. Blum took the floor and said what had to be said. "Let the aggressor nations search themselves first before attributing their own sins to countries that are not guilty of them, especially their would-be victims," he declared and added: "The countries that engineered the move that eventually led to the illegal attempt to tamper with my country's credentials may also wish to ponder how much their own prestige had been enhanced within and outside this Organization as a result of their antics and machinations of recent weeks. The answer is quite obvious to any observer of the UN scene."

Lashing further into the malcontent Arab and other delegations who accuse Israel of the very crimes they themselves are guilty of, Blum went on in powerful rebuttal: "While I do not wish to be drawn into this evident abuse

of the credentials procedure," he said, "I cannot refrain from pointing out the arrogant, frivolous and ironic character of the various anti - Israel statements made in the course of this debate. My country has been the target of ongoing aggression by a group of states ever since its establishment in 1948. That group of states," he continued, "has over the past 34 years flagrantly and continuously violated the UN Charter and the basic precepts of international law vis - a - vis Israel, most specifically Article 2 (4) of the Charter which prohibits the use, and even the threat, of force against the territorial integrity and political independence of any state and Article 2 (3) which enjoins all Members of the UN to settle their international disputes by peaceful means.

"The countries which engineered the move that culminated in the anti - Israel statements," Blum stated before the guilt - ridden Assembly, "have done everything in their power over the past three decades and more not only to harass my country in every conceivable manner, including the recurrent recourse to the unlawful use of force, but also to attempt to annihilate it and wipe it off the face of the earth. They have even created a terrorist organization for the specific purpose of promoting their unrelenting efforts to destroy Israel....having failed in their criminal designs against my country, they have been fulminating against it here at the UN..."

This whole satanic attempt by Israel's enemies to eliminate her from the scene brings to mind this passage from Isaiah chapter 8:

"Make an uproar, o ye peoples, and ye shall be broken in pieces. And give ear, all ye far off countries; gird yourselves, and ye shall be broken in pieces; take counsel together, and it shall be brought to nought. Speak the word, and it shall not stand -- for Emanu El."
