

SARANN KNIGHT FILES FOR CITY COMMISSION



My decision to once again become a candidate for the Office of City Commissioner was not an easy one, but I am acceding to the wishes of many supporters who are residents of Ward 3 who feel that they have a right to choose their representative on the City Commission.

Four years ago, when I lost the election to the then incumbent, Roy Woofler, by 73 votes, I felt that the majority (scant as it was) had made the choice and I accepted the loss with minimal regret and no bitterness. When the incumbent resigned the position, and the city fathers, with the exception of Mayor William Briare who supported me to fill the vacancy by his nomination and his vote, ignored me and the demonstrated wishes of hundreds of Ward 3

ABSENTEE BALLOT RULES FOR MAY 3RD PRIMARY

The Primary Municipal Elections for Las Vegas, North Las Vegas, Boulder City and Henderson will be held on May 3rd. For those people who will be out - of - town and require an absentee ballot, requests for absentee ballots for the cities of North Las Vegas, Henderson and Boulder City should be directed to the respective City Clerk in care of the City Hall; and

for the City of Las Vegas, absentee ballot requests should be directed to the Clark County Election Department, 400 Las Vegas Boulevard South, Las Vegas, Nevada 89101. All absentee ballot requests must be received in the respective offices no later than April 26th for the May 3rd Primary Election. Requests received after that date, cannot, by law, be honored.

residents, I accepted their decision, albeit with understandable reservation.

I seek the office now because I have been convinced that citizens who live in Ward 3 are entitled to a choice and my candidacy will give them a choice. I feel now, as I did four years ago, and for years leading up to my candidacy, that Ward 3 residents have never had true representation on the City Commission.

It has been, and is, a source of frustration and dismay to us who live in the District that it is one of the two areas that has experienced no growth, no change, and no prosperity despite the overwhelming growth and prosperity that has been the fortune of Southern Nevada over the past few years. Indeed, the economic status of that area is worse than at any time I can remember, and I have been a resident for more than 40 years.

I believe that unemployment and crime are the major problems to be addressed. I am distressed that programs for our youth are practically nonexistent. The correlation between unemployment and crime is obvious and worsening. I hold jobs and meaningful job training as a major priority. I am strong for police protection and as strongly opposed to police harassment.

Ward 3 cuts a wide East-West swath across the City of Las Vegas and encompasses within its environs residents of every ethnicity, most of whom are all victimized by the same economic problems. I believe I can serve best the interests of all Ward 3 residents without neglect to the future and the continued planned progressive growth of the entire city. I believe I can make a difference on the City Commission.

In - office absentee voting will also be available starting April 12th through April 26th at the City Clerks' Offices of North Las Vegas, Henderson and Boulder City for residents of those areas. Residents of the City of Las Vegas may cast an absentee ballot by coming to the Clark County Election Department, 400 Las Vegas Boulevard South.

After April 26th, absentee voting will be restricted to those people who, due to some emergency, are either confined to their homes or suddenly called out - of - town.

It is important that all absentee voters be aware that their voted ballots must be returned to the respective offices no later than 5:00 P.M. on Election Day.

LONDON (WNS) -- British Jews are rapidly decreasing in number and the average age of the survivors is rising, according to a demographic survey published here. Between the early 1960's and the late 1970's, the Anglo-Jewish population fell from 410,000 to about 354,000, a massive drop of 56,000 in only 15 years, says the demographic research unit of the Board of Deputies of British Jews.

JERUSALEM (WNS) -- The government and the World Zionist Organization will establish a joint fund of \$1 million to assist with loans to Israelis returning to Israel after an extended stay abroad. The decision was made by the joint committee of the government and the WZO to promote the return of Israelis. It also decided to establish joint committees in the U.S. and in France to handle the loans.
