This week Secret Witness will pay up to \$1,000.00 cash rewards for information leading to the arrest and indictment of the following suspects:

**HOMICIDE VICTIM - \$1,000.00 REWARD**

On Wednesday, July 13, 1983, at approximately 5:30 p.m., EUGENE LUCERO was last seen alive in the Green Valley area at the home of a fellow worker. At that time he was operating a 1980 silver Subaru, 2-door, bearing Nevada license plates TDE785.

LUCERO is described as a latin male, 41 years of age, 5'7" tall, 135 pounds, last seen wearing a pair of blue walking shorts, no shirt or shoes.

On Thursday, July 14, 1983, at approximately 1:00 p.m., the body of LUCERO was found on the side of the road next to the southbound lanes of I-15, near the 7.3 mile marker on the Nevada side of Stateline. He had been bound, hand and foot, and had received several blows to the head.

On Monday, July 18, 1983, the above-mentioned vehicle was located in Lakewood, California.

We are requesting the public's assistance by asking for any information related to this homicide.

**ROBBERY - UP TO \$1,000.00 REWARD**

At 8:00 p.m., on July 17, 1983, a black male, approximately 30 years of age, medium build, wearing a brown jogging suit, brown baseball type cap with a white emblem, brown driving gloves and carrying a brown and green checked gym bag, entered Happy Dave's Casino, located at 1201 Las Vegas Boulevard South, produced a weapon and demanded money. He took an undetermined amount of cash from the employee and placed it in the gym bag. He demanded more money and after the employee could not

comply with his demand, the suspect struck her in the face, knocking out her tooth, and shot her in the hip. He then tied her up and fled the casino.

**ROBBERY - UP TO \$1,000.00 REWARD**

On July 18, 1983, at 2:57 a.m. the Manager of the Cinedome Theatres, located at 3200 South Decatur, was confronted in the office area by a white male adult, armed with an unknown caliber handgun. The suspect pointed the weapon at the Manager demanding the day's receipts. After taking an undisclosed amount of currency, the suspect shot the Manager in the upper left chest area. The suspect then fled on foot; no further details available.

The suspect is described as a white male, early 20's, 5'10" to 6' tall, 165 pounds, light blonde shoulder length hair, medium build, short sleeve black T-shirt with blue levis.

**ROBBERY - STRONG ARM/BATTERY - UP TO \$1,000.00 REWARD**

On July 20, 1983, at 1:30 a.m., the victim was stopped at the intersection of Vegas Valley and Eastern wherein four black male subjects pulled up beside him. Three of the suspects got out of the vehicle, knocked the victim off his motorcycle. One suspect took the motorcycle and the other two beat him in the face, breaking his nose and fracturing his jaw. Suspects are described as:

1. Black male, black hair, brown eyes, 6', 150 pounds, thin build, early 20's, with large afro and glasses.

2. Black male, black hair, brown eyes, 6', 165 pounds, large build, early 20's with a large afro.

3. Black male, black hair, brown eyes, 6', 165 pounds, large build, with a large afro.

4. Black male, black hair, brown eyes, 6', 150 pounds, thin build.

Suspect vehicle described as an older model Ford, 2-door, gold in color, with a partial Nevada License Plate TGH???

**FORGERY SUSPECT - UP TO \$1,000.00 REWARD**

John Barrun Moore, also known as James Adam Hartford, pled guilty to 2 counts of forgery. He was scheduled for sentencing in District Court, Department No. 2, on February 18, 1983, of which he failed to appear.



On February 23, 1983, District Court Judge James Brennan issued a Bench Warrant for the arrest of John B. Moore, with no bail.

This suspect is charged with passing approximately \$30,000.00 in forged counterfeit checks drawn on various banks and businesses in the Las Vegas area.

John Barrun Moore's birthplace is San Bernardino, California. He is described as white male, 5'9" tall, 210 pounds, brown hair, blue eyes. His birth date is October 25, 1946.
