

# House Committee Acts To Bar U.S. Contacts With PLO, Arms Sales To Jordan

(Continued from page 1) and wants to grant King Hussein's desire to acquire F-16 jet fighters, mobile

ground-to-air anti-aircraft missiles and other weapons. But the committee's amendment would prohibit such sales "unless the President has certified to the Congress that Jordan is publicly committed to the

recognition of Israel and to prompt entry into direct peace negotiations with Israel." Hussein has so far refused to enter into direct talks.

adds: "In accordance with that policy, no officer or employee of the United States government and no agent or other individual acting on behalf of the United States government shall negotiate with the Palestine Liberation Organization or any representative thereof."

The admendment on the PLO is reportedly intended to bar the Administration from circumventing a 1975 agreement with Israel

that the U.S. will not recognize or negotiate with the PLO until it recognizes Israel's

right to exist. The admendment stated that the U.S. "hereby reaffirms this policy." It

Before the subcommittee's actions can become law, they have to be approved by the full House, reconciled with the Senate's version of the foreign aid bill and signed by the President.

dress by declaring that "Israel is not the cause of war in the Middle East, in spite of all the mythology to the contrary...I had never heard before I went to the UN the theory that Israel was the only obstacle to peace and well-being in the Middle East..."

President Gemayel, in his weakness and dishonesty, had on several occasions blamed Israel for the Phalangist massacres perpetrated at the Sabra and Shatila camps. Herein, in part, lies the current tragedy of Lebanon; also of his lack of understanding of the role the Druze and the other elements there must play in a democratic Government. Moreover, the U.S. must take some blame for the current state of affairs. Much of the tragedy might have been avoided had the Administration not put roadblocks against Israel's 1982 'Peace for Galilee' campaign which prevented the Israelis from completing the ouster of the PLO and the Syrians from Lebanon.
