

**Eugenia Pintos Ohrenscha11
Applicant For District
Judge, Department Twelve**



Eugenia Pintos Ohrenscha11, a resident of Las Vegas, Nevada since 1969 and member of the Nevada State Bar Association, has applied for appointment as District Court Judge, Department 12.

Her qualifications include her service with twenty person National Committee to Study Improvements in Federal Courts and the Federal Judiciary Machinery. She has authored major law review articles on subjects such as tariffs and trades, antitrust, the quality of legal education, studies in the problems in criminal procedure involving multiple prosecutions, and has co-authored a basic working paper with the past president of the American Bar Association on The World Peace Through Law Conference in 1965.

She was also named at the 1979 annual meeting of the American Bar Association as the outstanding person to have participated as research associates on "Williston On Contracts" by its author Dr. Walter Jaeger.

She has been involved in a substantial number of landmark cases both before the United States Supreme Court and the Nevada State Supreme Court, the last of which, Fritz & McDermond vs. Seimens materially strengthened protection for Nevadans investing in foreign corporations that they are not directly involved in. This was a unanimous decision by the State Supreme Court.

While operating her private law practice she has also taught courses in Business and Real Estate Law as well as courses in Criminal Procedure and Criminal Evidence, directed primarily toward law enforcement officers, at Clark County Community College.

Eugenia Ohrenscha11 has also gained substantial experience in statutory construction and bill drafting by serving on the Nevada State Legislative Council Bureau Subcommittee in 1968-69 and through her work on the vital U.S. Senate Judiciary Committee.

She also has extensive experience in civil and criminal litigation, in land law, has served on the Nevada State Bar Association committee on Administrative Law and is fluent in five languages including their legal vocabularies - this will be another valuable asset to our Nevada Judiciary, and our tourist based economy.

Eugenia Ohrenscha11 is married to Jack Ross, a member of the Jewish Community and has two children. Her son is an honor student at the Hebrew Academy.

Of all the applicants, Eugenia Ohrenscha11 is the only one being considered from our Jewish Community.

UN Secretary General Addresses First Jewish Audience

The Secretary General of the United States, Javier Perez de Cuellar delivered his first address before a Jewish audience when he spoke last Thursday before the Annual Meeting banquet of the American Jewish Committee in New York. It was a risky undertaking for both sides.

The AJC risked misunderstanding in the Jewish community for providing a platform for the highest official of the United Nations which is rightly perceived as the "bulliest" international platform of political anti-Semitism in the world today. The UN Secretary General risked alienating the Soviet Union, the Arab and Third World blocs who clearly were not happy at his accepting AJC's invitation.

As it turned out, Secretary de Cuellar's talk was not as bad as some feared it might be, nor was it as good as some hoped it might be. The gains in his talk were several-fold:

1) He acknowledged several times that "positions taken by several bodies of the United Nations have aroused misgivings and even resentment." And he flatly said that "there is no excuse for mistakes or wrong judgments or erroneous

courses." Jews took that euphemism to mean that the Secretary General said there was no excuse for the horrendous attacks on Israel and Zionism, the incitements to hatred by Arab nations and the Soviet Union which consistently violate the UN Charter and UN declarations.

2) He affirmed repeatedly the "rich tradition of tolerance, compassion, and magnanimity" of the Jewish people, as well as "the broad and humane concern of the American Jewish Committee with the problems of mankind." Those affirmations, among others, were taken as implicit rejection of the vicious defamation of the Jewish people and of Judaism by Iran, Syria, and Libya at the UN in recent months.

The UN official also spoke of the need "to strive for an arrangement which encompasses the security of Israel and the other states in the area as well as the political and human rights of the Palestinians."

In his response Howard Friedman, AJC president, respectfully pointed out that "the political behavior of UN member nations will need to be altered if UN credibility is to be restored."

WASHINGTON (WNS) — Acting on a joint Congressional resolution President Reagan has proclaimed May 6-13 as National Jewish Heritage Week. The measure was unanimously approved by both houses of Congress and enacted by the President on March 28, 1984. The resolution was introduced by Sen. Alfonse D'amato (R. N.Y.) in the Senate and by Rep. Joseph Addabbo (D. N.Y.) in the House.

NEW YORK (WNS) — More than 1,000 children of Holocaust survivors are scheduled to gather here during the Memorial Day weekend, from Sunday, May 27 through Tuesday, May 29, to "demonstrate a commitment to the legacy which we accepted from our parents at the World Gathering of Holocaust Survivors in Jerusalem, in 1981," said Menachem Rosensaft, chairman of the International Network of Children of Jewish Holocaust survivors.

TEL AVIV (WNS) — The cost of living index rose during March by 10.7 percent, a new record for that month, the Central Bureau of Statistics announced. It brought the inflation rate to 42 percent during the first quarter of the year, with a 240 percent index rise during the past 12 months.
