## Vucanovich Makes It Official -- Will Seek Second Term

RENO, Nevada -- Nevada Congressman Barbara Vucanovich announced that she will seek a second term in office.

Vucanovich said her decision to run was expected, and that the real importance of her announcement was to "compare the opportunities our people have today, with what they were two years ago when I originally sought your support." The nation has moved ahead in the critical areas of reducing joblessness, controlling inflation, and creating a fundamentally stronger national economy she said, and the main reason for that is "because we've made tough economic decisions" with an eye towards long term, not short term, goals.

She characterized the current national debate as one of "failed liberal policies of the past versus the conservative policies in place that are proven successful." She said congressional debate over the next two years would continue to center around the liberal-conservative split, making continued conservative representation for Nevada of utmost importance.

Vucanovich said she has played a major role in this national debate, taking leadership positions in the Congress and "following my beliefs by casting votes intended to recreate a new, strong economy by controlling government growth and working to correct Congressional deficit spending habits."

But Vucanovich said the most appealing part of her job as Congressman has been "helping Nevadans and carrying their beliefs, needs, and concerns to Washington."

She pointed out that her tenure as Congressman has been characterized by extraordinarily strong constituent services, including the opening of district offices in Reno, Elko, and North Las Vegas...a first for Nevada.

In addition, Vucanovich said she has helped "thousands of Nevadans" solve problems in their dealings with the Federal Government.

Perhaps most importantly, Vucanovich points to the fact that she has, to date, answered over 50,000 letters from Nevadans, proof that she is "truly a representative of this State."

Vucanovich said her campaign "must become a serious, informed and frank discussion of what

path our nation should take." She continued, "This is not a time for gimmicks and protests. Rather, it is a time for contemplation and careful planning."

She called for reducing the federal deficit by allowing the economy to expand, and tightly controlling federal spending policies, including the Pentagon. In addition, she asked Nevadans to join her in "promoting the traditional family values that have made this state and nation great."

Vucanovich concluded by saying, "That's how this campaign should be concluded...no gimmicks, and maybe no surprises. Just a serious look at serious representation. To frame this campaign in any other manner is not only disrespectful of this state and nation, but also constitutes a dangerous lack of appreciation for the seriousness of government."

## Bob Price Files For Re-Election

Assemblyman Bob Price filed for re-election to the District 19 seat he has held for the past 10 years.

Price chairs the Assembly Committee on Economic Development, Tourism and Mining. In the 1983 session this committee processed legislation that should affect the daily lives of most Nevadans in the next decade.

They created the Commission for Tourism and the Commission on Economic Development, which will for the first time put in place statewide efforts to promote Nevada. This legislation will give great help to the local boards and commissions which will give a unifying look to all promotions.

Also it created an office of Film Commissioner as part of the commissions on Economic Develop-

ment. This office will help producers of motion pictures, television and commercials to use Nevada as location for their productions.

A blue ribbon inter agency co-ordinating committee chaired by the governor was created to review all the promotional efforts and make the end product compatible with other efforts in the same field.

Other important legislation that was processed allows Nevada cities and counties to participate in the federal Enterprise Zone Act of 1982 and the private business economic revitalization and diversification corporations to aid Nevada businesses finance their projects.

Price, a realtor and his wife, Nancy Brogan Price, a stock broker, live out in the district at 1809 Renada Circle, North Las Vegas.

## Moore Wins Arm Wrestling Championship At Imperial Palace

Meeting Moore in the final match was Steve McMichael of the Chicago Bears. With teammate Otis Wilson, McMichael claimed second place for the Bears. Third and fourth places went to the Pittsburgh Steelers and the Cleveland Browns.

Defending champion Johnny Walker retained his title in the Professional Men's Light Heavyweight event. Last to go down

to Johnny's crunching forearm was Clay Rosencrans.

The Women's Professional Arm Wrestling Championship went to a new winner, however. Sharon Brandef of Canada overcame Angie Miranda of Buckey, Arizona, in a hard-won match to take the title and top prize money of \$1,000. The championship match came after a record-breaking match between defending champion Jackie Allard and challenger Deb Darling, which lasted two minutes, 40 seconds.

Although that match and another ended in slips (a technicality allowing a re-start), Deb Darling took the match when the referees put the two women in a power-grip position. Darling was later defeated by Brandef on her way to the title.
