No one group shall dictate water policy.

I believe criminals should be required, if found guilty, to reimburse their victims and pay a portion of the costs of their incarceration. Child pornography possession laws should be toughened.

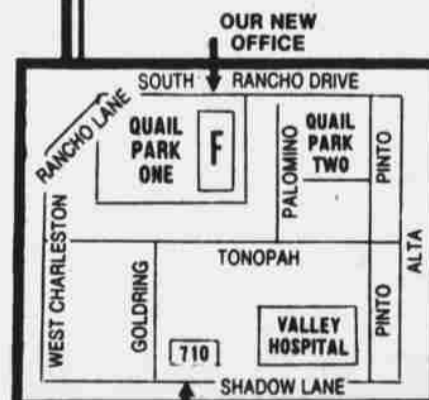
