Two Prominent Australian Jews Were Targeted For Assassination

MELBOURNE (WNS) The Prime Minister's Office has declined to comment on a report that Labor Party leader Bob Hawke and two Australian Jewish community figures were the targets of an assassination plot by a Palestinian militant organization in the mid-1970's.

According to report, the plot was foiled by the Australian Security Intelligence Organization whose agents infiltrated the Palestinian group. The group was not identified.

Hawke has been Prime Minister Australia since March, 1983 when he defeated the Liberal Party go-vernment of Malcolm Fraser. At the time of the alleged assassination plot, about 10 years earlier, he was president of . the Australian Council of Trade Unions and an outspoken friend Israel.


