Judge Guzman Seeks District Court Judge - Department 6



LAS VEGAS -- Fernando Guzman, who currently serves as Juvenile Court Referee for the District Court of Clark County, has entered the race for the position of Judge in District Court Department VI.

"In my capacity as Juvenile Court Referee for the past four years," Guzman said, "I have presided as Judge over countless hearings in which juveniles have been charged with committing an offense or in which an allegation of abuse, neglect or custody has been filed against parents."

Guzman, a graduate of the University of San Francisco School of Law, served more than five (5) years as a Deputy District Attorney, and successfully prosecuted numerous felony cases. Prior to his appointment as Juvenile Court Referee, he was in private practice, emphasizing the areas of criminal law, juvenile law, immigration and domestic relations.

Working with law enforcement to ensure the protection of the community from convicted offenders is an ongoing priority. The work and energy dedicated will continue in dealing firm and swiftly with offenders.

An equal priority is the protection of children who have been abused and neglected. Those convicted of abuse or neglect must be dealt with using the full force of the law.

Married and having two children, Fernando Guzman will campaign on his background as a longtime Nevada resident, his experience in the Judicial System, and dedicated services to the people of Clark County.

"Since my admission to the Bar in 1974, I have dedicated myself to public service," he said. "As a Las Vegas resident for thirty (30) years, I feel

that I know the concerns and needs of the people of this county. I believe that I can best continue to serve the needs of the community in the capacity of District Court Judge."

Guzman, who was appointed to the position of Juvenile Court Referee in 1980, is a member of the National Council of Juvenile and Family Court Judges, a graduate of the Judicial College in Reno, Nevada, and a member of the Latin American Bar Association, as well as the Clark County and Nevada Bar Associations.
