## Kenny C. Guinn To Receive Humanitarian Award

LAS VEGAS — Kenny C. Guinn, president of the Nevada Savings and Loan Association, will be the guest of honor December 16 at the 1984 benefit dinner for National Jewish Hospital/National Asthma Center (NJH/NAC).

The campaign for the Denver-based respiratory and immune disease center will be held at Caesars Palace with a reception at 6 p.m. and dinner at 7. Black tie is optional for the \$200-per couple dinner.

Guinn will receive the NJH/NAC National Humanitarian Award, which is presented in Minneapolis and other cities to recognize persons who have demonstrated great humanitarian concern and outstanding community service.

A former teacher and school superintendent, Guinn held several teaching and administrative positions in California and Nevada and obtained his doctoral degree from Utah State University, Logan, Utah.

After 18 years in the education field, Guinn joined the Nevada Savings and Loan Association as administrative vice president in 1978. Within two years he was named to his current position.

Active in Las Vegas civic affairs, Guinn has served as chairman of the March of Dimes Walkathon, executive board member of the Boy Scouts and member of the Clark County Community College advisory committee.

Serving as dinner co-chairmen are Harry Wald, vice chairman of the board of Caesars Palace, and Fred Lewis, vice president of the Hughes Corporation, Summa Corporation and Hughes Properties, Inc.

NEW YORK (WNS) — Soviet Jewish Prisoner of Conscience Aleksandr Kholmiansky, a Moscow refusenik who applied to emigrate in 1978, entered the 33rd day of his hunger strike, according to latest reports from the New York Conference on Soviet Jewry. He is reported to have been on a hunger strike since September 13 and is being forced-fed within the prison hospital. He is reported by his mother to be protesting his groundless imprisonment. He was arrested on July 25 and charged with "hooliganism."

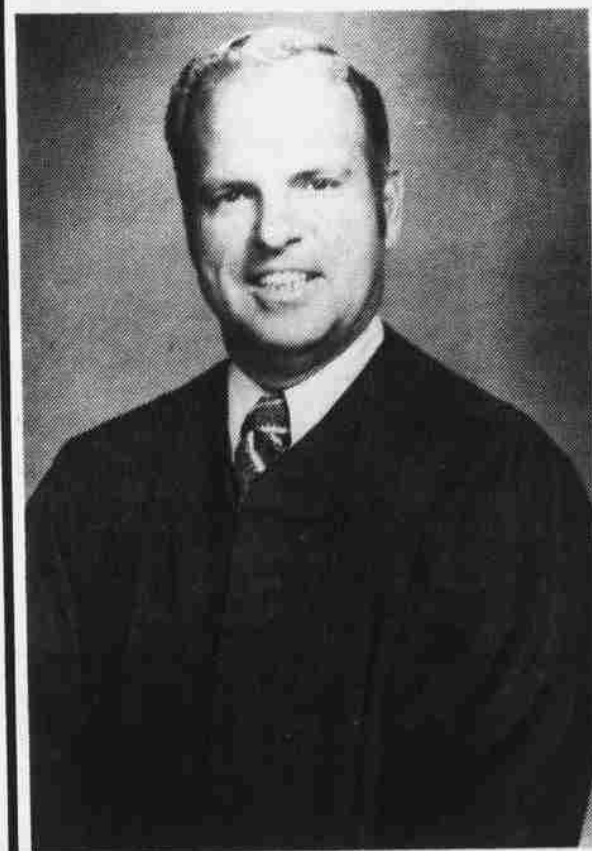

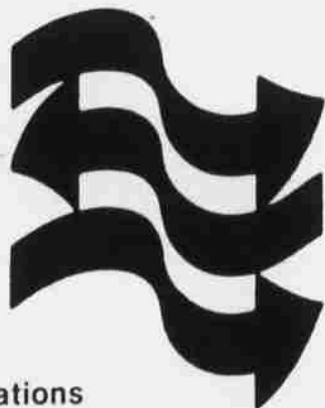
