#### **Jewish Family In Argentina** Receive "A Ghoulish Parcel"

NEW YORK, N.Y. - A package of human bones shipped through the mail in Argentina provide grisly evidence that unrepentant, undemocratic elements there continue functioning, according to the Anti-Defamation League of B'nai B'rith.

Rabbi Morton M. Rosenthal, director of ADL's Latin American Affairs Department, reported that such "a ghoulish parcel" was recently delivered to the parents of Patricia Uchansky Rubinstein, a young Jewish women who disappeared in 1977. with an enclosed note claiming that they were her remains.

Shocked, the parents took the package's contents - a skull, a jawbone, a femur and three ribs -- to a laboratory to determine their origin. The analysis revealed that they were male bones and therefore could not have been Patricia's skeleton.

Ms. Rubinstein's mother, Beatriz Serebrinsky, president of the Mar del Plato office of the Mothers of the Plaza de Mayo, a group of parents whose children were "disappeared" during the period of military rule said after the incident, 'We will not give up our fight even if they throw bones in our faces."

Describing the macabre mailing as "a horrendous act," Armando Fertitta, who was head of the Mar del Plata branch of the now dismantled presidential Commission on the Disappearance of Individuals (CONADEP), charged that it was done by "neo-facist groups who are trying to bring about another coup.

That there was some truth to his accusation was indicated when a group known as "Condor 33" claimed responsibility for the parcel.

Rabbi Rosenthal said the incident seems to be part of a wide-spread campaign of harassment which also includes anonymous phone calls to relatives of the disappeared which purportedly give details of their fate.

According to records maintained by the League, approximately 1500 Jews were among the thousands who were kidnapped, tortured and murdered during the military dictatorship which lasted from 1976 to 1983.

This act was also condemned by Dr. David Goldberg, the newly elected president of D.A.I.A. (the umbrella organization of the Argentina Jewish Community), who called is a "reprehensible reappearancae of the blood-thirsty politics that divided and nearly destroyed our country."

He went on to say that "this cruel tactic must receive the strongest repudiation by reinforcing the unity and solidarity of all people of good will of all faiths.'
