Concern Expressed Over Condition Of Three Soviet Jewish Activists

NEW YORK (WNS) -The National Conference on Soviet Jewry (NCSJ) has expressed "grave ditions of Aleksandr Kholmiansky, Yuli Edelstein and Yakov Mesh. Soviet Jewish activists and Hebrew teachers currently awaiting trial.

Kholmiansky, arrested in July for allegedly "possessing weapons and ammunition," is currently in the third month of a hunger strike to protest the beatings he received when he arrived in prison.
