The documents pre- District viously released by the Washington that the government mention that Mengele, considered the most wanted war criminal still at large, may have sought a visa at the Canadian Consulate in Buenos Aires under the alias of "Joseph Menke." There is no knowledge that he ever entered Canada. The documents were obtained under provisions of the Freedom of Information Act.

American intelligence was informed of the visa application made in the name of "Joseph Menke" and replied to the Canadians with information about Mengele, but subsequent follow up, if any, has not been revealed. U.S. intelligence has established that Menke was an alias used by Mengele.

The four pages of documents, three of which reportedly are Canadian records held by Army intelligence, were withheld because they "reasonably could be expected to cause




