


The city's effort to attract big name stars in the cultural world - a counterpart to our ongoing successes in the entertainment world - is now paying off. This month, the major "Benini in Las Vegas" exhibition opened at the Charleston Heights Arts Center and the Reed Whipple Cultural Center and will continue through Tuesday, March 26th.

Benini is an enduring master of contemporary art, hard to classify and yet his work is easy to recognize as undeniably Benini.

His is the color-potent language of myth, exploration and future visions. Benini's trademark is the Rose. Most paintings have a rose in them or are themselves the embodiment in design and shaped of a rose fixed in brilliant color. Intrigue is here - in the archetypes of the symbols of feminity and change, in the folds of the roses, and in the overall composition of symbols.

Benini is a modern-day visionary, creating a body of work richly filled with images, ideas and color brilliance. His work is in more than 550 private and public collections. This is Benini's 77th one-man exhibition to date, but the first time Las Vegans have had the opportunity to see paintings like this.


