

Las Vegas Activist
Michael Cherry Meets
Meir Rosenne,
Israel's Ambassador To U.S.



Michael A. Cherry, a partner in the Las Vegas law firm Manos & Cherry, Ltd., and an activist in the local Jewish community met Israel's Ambassador to the United States, Meir Rosenne, following that diplomat's keynote address to

selected members of B'nai B'rith, recently, at the South Coast Plaza Hotel in Cosata Mesa, California.

An executive delegate to the 122nd annual B'nai B'rith District Four convention, Cherry also met with the presidents of B'nai B'rith International and B'nai B'rith District Four in sessions setting policy for the world's largest Jewish service organization. District Four is the B'nai B'rith administrative division for 10 Western states and the Canadian province of British Columbia.

A member of Nate Mack-Las Vegas B'nai B'rith Lodge, Cherry is a past president of District Four and a permanent member of its executive board. He is also past president of Las Vegas' Congregation Ner Tamid, and is a member of the board of the Jewish Federation of Las Vegas.

The four day convention, which includes a major fund raising luncheon benefitting the youth serving agencies of B'nai B'rith, culminated with a black-tie-optional banquet and dance at which internationally known comic Yakov Smirnoff entertained.

WASHINGTON (WNS) — The Senate voted to authorize the \$250 million economic aid for Jordan requested by the Reagan Adminisatration. But it will be spread over 27 months, rather than the 15 months the Administration requested.

VIENNA (WNS) — The Netherlands will erect a memorial at Mauthausen, the former Nazi concentration camp, for the Dutch victims of the Holocaust. Several hundred Dutch citizens were murdered in Mauthausen during World War II. The Dutch memorial will be the 17th of its kind at Mauthausen.
