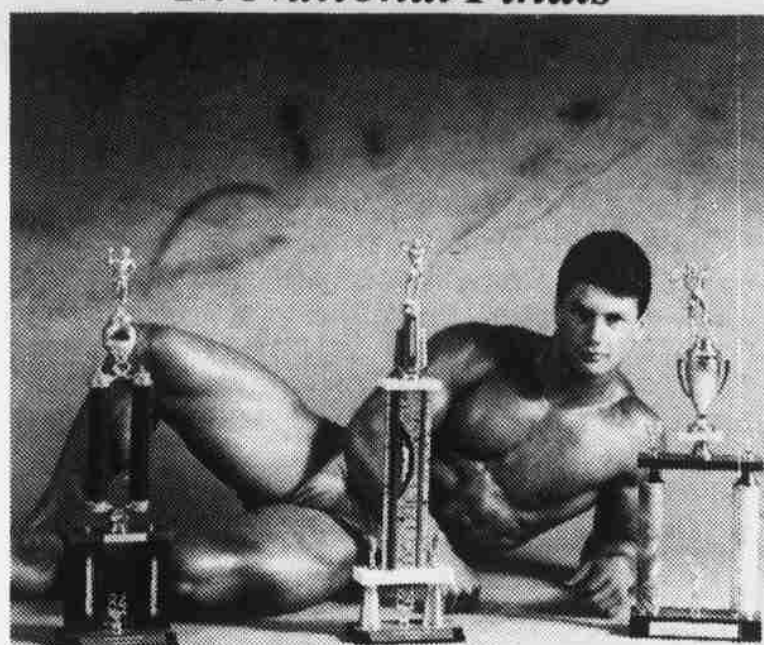


Las Vegas Sabra Wins Second Place Trophy In National Finals

Cabinet Sets Up Special Unit To Improve Anti-Terrorist Measures

JERUSALEM (WNS) — A seven-minister committee has been appointed by the Cabinet to study tougher penalties and preventive measures against terrorism. This was the upshot of the weekly Cabinet meeting under the shadow of the recent double murder near Afula. The Cabinet decision seems to mean that there will be no immediate move to introduce the death penalty by new legislation -- although, as Premier Shimon

B'nai B'rith Denounces Bombing Of Synagogue In Copenhagen

WASHINGTON — B'nai B'rith International denounced the bombing of a synagogue and an American airlines office in Copenhagen, Denmark, as "a despicable and cowardly act."

Dr. Daniel Thursz, executive vice president of the Jewish service organization, expressed hope that Danish authorities "will quickly apprehend those terrorists responsible and bring them to justice." The terrorist Islamic Jihad group said that it had bombed the sites in which at least 14 persons were injured.

Dr. Thursz said that B'nai B'rith has expressed its concern to Rabbi Bent Melchior, head of the Danish Jewish community and a B'nai B'rith leader, and offered to aid "in every way possible."

"We are particularly concerned because this is the first such incident in Scandinavia and comes against a backdrop of increased neo-Nazi activity in Denmark and the appearance of anti-Semitic slogans on the streets of Oslo, Norway."
