**Arab University In Nablus Closed For Two Months**

JERUSALEM (WNS) — The military authorities ordered the closing of the Arab University of A-Najan in Nablus for a period of two months.

The army spokesman said the university was ordered closed because of several conventions and incitement acts by terror organizations inside the campus. However, the local Arab population interpreted the closure as a collective punitive measure, following the murder of an Israeli in downtown Nablus. The national university of A-Najan (which is the official name of the institution) is considered one of the strongholds of the

PLO in the territories. One of the two youths who were killed two weeks ago preparing an explosive device was an excelled student at the university. The man who two weeks ago attacked children in downtown Jerusalem was also described as a student at the university.

But an official communique of the army spokesman only referred to inflammatory material found in a search of the offices of the student union in the campus. The army said the material promoted terror activities against Israel.

Meanwhile a military court in Ramallah approved the administrative arrest of Zaid Abu-Ein, one of the 1,150 released terrorists in the May prisoner exchange with Ahmad Jibril's Democratic Front for the Liberation of Palestine. The court session was held behind closed doors.

According to the Israeli authorities, Abu-Ein incited Arab students to fight against Israel, until Palestine is liberated. He did not heed to warnings issued to him, and allegedly met with Arab students from Gaza, and discussed with them the hijack of an Israeli bus — an operation which did not materialize. Abu-Ein is the first case of administrative arrest in a long time. In recent years, the government refrained from using this measure which is a legacy of the British Mandatory emergency law.
