**Arm Wrestling Tournament Taped At Imperial Palace To Air Beginning In September**

Professional Men's Light Heavyweight Championship

The broadcast schedule has been announced for the Pro Football "Super Classic VIII" Arm Wrestling Championship held in Las Vegas. The tournament was taped at the Imperial Palace Hotel & Casino June 9, 1985.

ESPN Sports Network will air the show in six

half-hour and one one-hour segments. The first four shows are scheduled as follows:

- Show #1 Sept. 3, 4:30 p.m. PDT (7:30 EDT)
- Show #2 Sept. 10, same time as above.
- Show #3 Sept. 17, same time as above.
- Show #4 Sept. 24, same time as above.

The first four shows will be repeated on Saturday at 9:30 p.m. PDT beginning Sept. 28.

Shows #5 and #6 and a one-hour over-view will air later in the fall.

Two men from each NFL team competed in "Super Classic VIII." Fred Dean and Dwain Board of the San Francisco 49ers took the championship. Second place went to Curt Marsh and Jeff Barnes of the Los Angeles Raiders.

Separate competition paired off professional men and women arm wrestlers. Victory in the men's light heavyweight division went to John Buononato of Santa Ana, California. Sharon Brandes of Vernon, B.C., Canada, successfully defended her title.

Sponsor of the event was Myoflex Pain Relief Rub. Promoter was Arm Wrestling International (AWI) under Tony Celeste, President.

The Imperial Palace hosted the popular event. The tournament was taped before a live audience in the hotel's showroom.

**Israeli MIA May Be Alive In Syria**

JERUSALEM (WNS)

— A glimmer of hope has emerged that an Israeli soldier missing in action from the war in Lebanon is alive in Damascus, where he is being held prisoner by the Democratic Front for the Liberation of Palestine, an extremist group led by Nayef Hawatmeh. The whereabouts of Zecharia Baumel was

reported by Jordan TV, but no other details were given.

Baumel is one of four soldiers still missing. He, Zvi Feldman and Yehuda Katz were reported missing near Sultan Yaackoub in eastern Lebanon following a tank battle with Syrian forces in 1982.

Another soldier, Sasmir Asad of the Druze village of Beit Jana in the Galilee, was captured near Sidon during another battle. Premier Shimon Peres told a group of families of missing soldiers that Asad was being held in Damascus by Hawat-

meh's group. The Premier said Israel is holding Syria responsible for the fate of the missing soldiers.

Peres immediately initiated diplomatic action in an effort to obtain Baumel's release and his return. He asked U.S. Ambassador Thomas Pickering to contact Richard Murphy, Assistant Secretary of State for Near Eastern and South Asian Affairs, who was in Jordan to try to get more information on Baumel's fate. Upon his arrival at Ben-Gurion Airport, Murphy said he had no further information.
