activities in the territories. The source sharply attacked the rapprochement between King Hussein and Arafat, saying that as a result Amman was losing grounds to Arafat in the territories. He added that Hussein's rapprochement had dealt a serious blow to the chances of peace with Jordan, because Arafat's Fatah group was the main force behind the renewed wave of terrorist activities.

The source said that the eight-man gang caught aboard the yacht Casselredit by the Israeli navy last month, had been intensively trained in Algeria to go on a killing mission in Kiryat Shmona.
