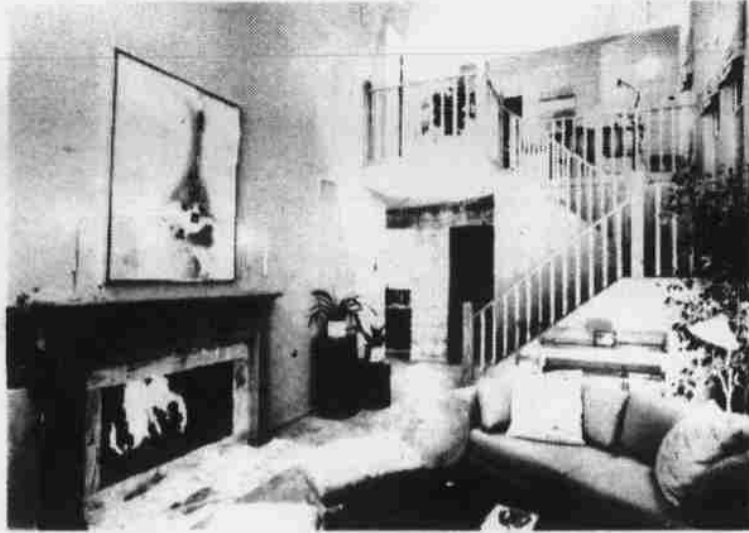


# Woodbury Homes Are The Best

## Anti-Semitism On Rise Wiesel Warns In Accepting Henrietta Szold Award

NEW YORK — Hadassah, the Women's Zionist Organization of America, presented author Elie Wiesel with the 1985 Henrietta Szold Award for distinguished humanitarian service at a banquet during the 71st Hadassah National Convention at the New York Hilton Hotel.

In accepting the award, Wiesel -- whose work on the Holocaust and other Jewish themes have won him a worldwide audience -- warned that "anti-Semitism thrives and is spreading in Western democracies as well as in the communist world, and is becoming increasingly violent."

He also cited his own experience, following his outspoken criticism of President Reagan's trip to a cemetery in Bitberg, Germany earlier this summer as evidence, that people are becoming more secure in their hatred toward Jews.

Following the Bitburg incident, Wiesel said he received numerous letters filled with hate and threats, which the author described as not unusual. What is unusual, he added, is that "for the first time their letters were signed -- names and addresses."

Anti-Semitism is on the rise in our country as well," Wiesel said. He noted that recent polls indicate that Israel is losing ground in American public opinion. Traditional left-wing supporters of Israel dislike the country's attempts at becoming a stronger and more secure nation, he observed and added that extremists of both the left and the right have established a rare common ground in their opposition to Israel.

countless occasions, yet knowing that this young man and his family will finally be free to practice their religious heritage freely is the best news possible at this time of extraordinarily low emigration."

Only 29 individuals were allowed to leave in August of this year, for a total of 681 for 1985 to date. This contrasts sharply with the more than 50,000 men and women who were granted exit permits in 1979, the year in which the most Soviets were allowed to emigrate. Since 1979, emigration figures have declined drastically each year. Congressman Gilman concluded, "This recent act on the part of the Soviet authorities is a glimmer of hope that progress in U.S. - U.S.S.R. relations can be achieved when implementation of the international treaties and charters, such as the Helsinki Final Act, to which the Soviet Union is signatory, takes place. Let us hope that the next six months bring about the freedom of other long-term refusniks and Prisoners of Conscience as well."

Dr. Nashpitz was also "adopted" by the Alpha Omega Dental Fraternity, who have worked tirelessly on his behalf. Dr. Nashpitz, his wife and young son are expected to arrive in Israel in several weeks.

## Former Prisoner Of Conscience Mark Nashpitz To Receive Exit Visa For Israel

Congressman Benjamin A. Gilman (22nd District - New York) announced that he had received word from reliable sources that long-term refusnik and former Prisoner of Conscience Mark Nashpitz, a 37-year-old dentist from Moscow, had finally, after 15 years, received his exit visa for Israel. "This is indeed very positive news -- news that we have hoped for for 15 long and difficult years. I am highly gratified by this turn of events, and I hope that it represents a turning point in Soviet policy," Congressman Gilman said.

Congressman Gilman has, since his election to Congress in 1972, taken an active role in seeking permission for the emigration of Mark Nashpitz. Nashpitz first applied for an emigration viszov in 1970, and he was then refused on the grounds that he was the relative of an illegal emigrant. Mark's father defected from the Soviet Union in 1956, when Mark was eight years old. Following his emigration refusal in 1971, Mark was arrested in 1972, charged with draft evasion, and sentenced to one year in in-

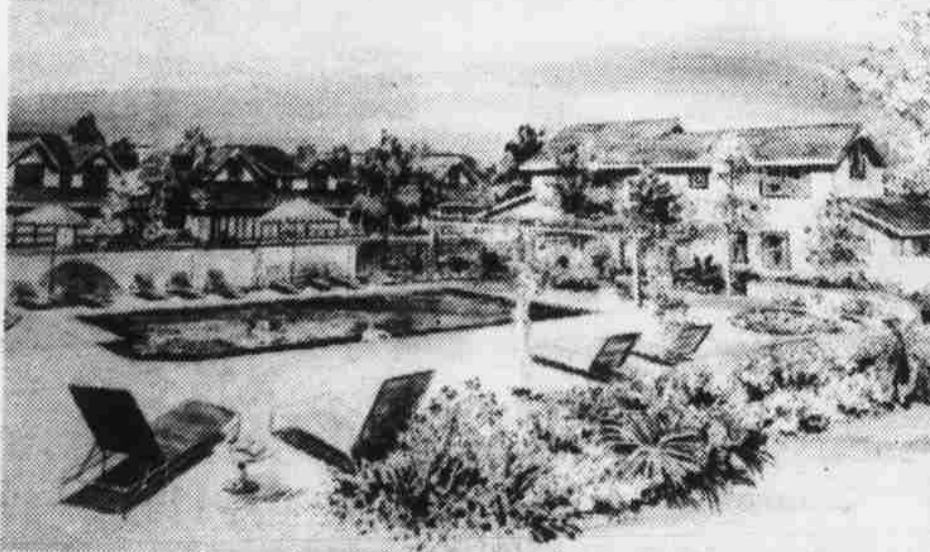
ternal exile. In February 1975, he was again arrested during a protest in front of the Lenin Library which lasted only a few minutes. At that time, Mark was sentenced to five years in internal exile in a town on the Siberian-Chinese border.

Since his release in 1979, Mark and his wife Ludmilla, whom he met while in exile, and their five-year-old son, Benjamin, have lived in Strunino, which is approximately 150 miles from Moscow. Mark has only been able to obtain employment there in a mortuary. As he lamented to Congressman Gilman in January 1985, during a Congressional delegation trip to the Soviet Union, "They only allow me to work on the dead, not the living."

Congressman Gilman was requested by Nashpitz' parents, who live in Israel, to petition the Soviet government on their son's behalf during his second term of imprisonment. In 1976, Gilman filed a petition and a brief with the Soviet Procurator General and was followed up by numerous public and private appeals over the years.

"Since my election to Congress, which roughly coincides with Mark's first refusal, I have worked ceaselessly to safeguard his rights and to secure a reunion with his aging parents," Rep. Gilman said. "We explored every avenue on
