The Las Vegas Hilton recently unveiled four \$25 slot machines on its casino floor that can yield a nearly 98 percent return on a player's investment, a spokesman for the resort's slot department said.

The machines, all brand new models, paid out a total of \$245,150 in winnings in the first 30 hours of operation. While only two others exist in the state, one in Lake Tahoe and the other in Riverside, the Hilton is the first casino to add the \$25 slots in Las Vegas.

"Obviously, we think it's going to be a success because we put four of these machines on the floor," said Cecil Fredi, slot manager. "We're extremely serious about this."


The machines, which are three-reel, nonprogressives, take a one ounce pure silver token. One to three tokens can be played with a possible \$15,000 top jackpot pay-off. The token was designed in-house by the Las Vegas Hilton and manufactured by Nevada Coin Mart.

5,000 tokens were manufactured for use in the machines, but said Fredi, the hotel will have to reorder very soon because of the tokens popularity among collectors. "The tokens are being picked up by collectors all around the state."

The resort has plans to put more of the \$25 machines in the casino if these four slot machines continue to be as successful as they are at the present time.

A representative for Bally Manufacturing, the major manufacturer of slot machines, has been quoted as saying that the Las Vegas Hilton's \$25 slots are the "loosest" machines he has ever dealt with as a group.

"The significant thing about these is that you can play these machines at your own pace and you only have two percent against you," Fredi said.
