The gourmet kitchen supplies all that one would expect: microwave, self-cleaning oven, multi-function dishwasher, ample pantry space and, in some plans, kitchen islands and/or breakfast nooks.

Specific design features include attached, two-car garage; contemporary Spanish design with tile roof; and numerous energy-saving devices.

Security is provided by a perimeter wall with remote controlled wrought iron gate, an automatic garage door opener and a computerized individual home system.

Two large designer pools and jacuzzi spas are available at Lakeside at Sunrise Villas. The homeowners association provides maintenance of all common areas, including grounds, greenbelts and water features.

Barbie Trial Postponed Till 1987

PARIS (WNS) — A Paris Appeals Court ruling, broadening the charges against Nazi war criminal Klaus Barbie, has set back his trial date by at least a year. Barbie, who has been in French custody since his ouster from Bolivia in February, 1983, will not go on trial until early 1987, at the soonest according to court sources here.

The Appeals Court decided that the former Gestapo chief in Lyon, responsible for the mass deportation of French Jews and other atrocities during World War II, can be charged

with war crimes as well as crimes against humanity for which he has already been indicted. The court acted on the request of five associations of former resistance fighters and individual survivors of the anti-Nazi French underground.

Crimes against humanity, for which there is no statute of limitations, includes crimes committed against civilians, in Barbie's case, mainly Jews. War crimes, which are governed by a statute of limitations, include crimes against resistance fighters. The

Fist-Pounding Soviet Delegate At UN Unit Unleashes Anti-Semitic Diatribe

GENEVA (WNS) — A fierce attack on Israel by a fist-pounding Soviet delegate who likened Zionism to neo-Nazism triggered an angry three-way exchange pitting Israel and the United States against the Soviet Union at a session of the United Nations Human Rights Commission here.

"We have never heard such harsh language and such blatant hate at this UN forum," said one Western delegate referring to Soviet delegate Dimitri Bykov's tirade against Israel. The verbal warfare erupted in the course of a debate on measures against totalitarian ideologies and practices.

Representatives of Jewish non-governmental organizations attending the session said they could not recall when a Soviet delegate had been so openly anti-Semitic and so unrestrained in his

attacks on the U.S. as well as Israel.

Bykov alleged a spiritual, political and ideological relationship between Fascism and Zionism and accused Israel of practices in the Middle East that aped Hitler's laws and methods. He also charged that Jews helped Hitler to power and financed his war machine.

Ephraim Dubek, the Israeli delegate said he had never heard such virulent and vicious anti-Semitism in the Palais des Nations and doubted that even the Nazis ever resorted to such diatribes against Jews in the old League of Nations. He said he thanked God the USSR has no common borders with Israel because the Soviets "would have no qualms to unleash their tanks and armour on Tel Aviv and Jerusalem as they did in Budapest, Prague and Kabul and were on the verge of doing in Warsaw."

U.S. delegate Richard Schifter was drawn into the fray when Bykov accused the U.S. of harboring Nazi war criminals and allowing them to work for Radio Free Europe and Radio Liberty. "That criticism from the Soviet Union comes with particular ill grace because the poisoned fruit of a system which one thought came to an end 40 years ago has sprouted new roots in that country." He noted that the U.S. is a free country where the spoken word was not a basis for punishment. Individuals found to have been Nazi war criminals are deported, he said and recently one was extradited to Israel to stand trial.

court, by its ruling, now waived the statute.
