## Zimmer Bids For Secretary Of State

Las Vegas Assemblyman and business leader Barbara Zimmer announced she will seek the office of Secretary of State of Nevada, saying she is best qualified for the job.

"I am anxious to serve the people of Nevada in new ways," Zimmer said. "My business background, my legislative expertise and my talents as a tough manager will be a tremendous asset for Nevada."

A 49-year-old Republican, Zimmer emphasized her "track record" of legislative service and business ownership.

The two-term Assemblyman said her involvement with state government has prepared her for the Secretary of State's role in supervising Nevada elections, lobbyists and notaries public. She added that the role of chief recordskeeper is the kind of day-to-day work she "relishes" as a manager.

Zimmer also stressed her business experience. "Owning my own business has shown just how important it is to have some one in government who'll fight for the rights of business people," she said. She noted that the Secretary of State must work closely with the business community in recording all incorporations within Nevada and serving as "a local securities and exchange commission" to insure that Nevada-based firms make sound offerings.

Zimmer pointed to her tough stance on crime while serving in the legislature, stating, "We have to remember that the Secretary of State is also a member of the State Board of Prison Commissioners and plays a key role in our criminal justice system."

A Nevada resident for 25 years, Zimmer served as chairman of the powerful Labor and Management Committee during the 1985 Legislature. She has also held seats on Taxation, Judiciary, Transportation and the Legislative Interim Commission.

Zimmer is president and part owner of G & Z Distributing Company in Las Vegas and was part owner of Air Filter Company, Inc., for 10 years. She is also active with Girl Scouts, the Assistance League of Las Vegas and the Southern Nevada Gymnastics Association.

In 1981 Zimmer was appointed by President Reagan to serve on his Program Advancement Committee. She co-chaired the Nevada Reagan-Bush re-election effort in 1984 and served on Governor List's Local Employee-Management Relations Board.

Zimmer holds a B.A. in Political Science from the University of Nevada-Las Vegas. She is married to Larry Morgan and has three children, Stephanie Gengler 27, Michael 24 and Tracy 21, and one granddaughter, Jamie 2-1/2.

## Brown Enters Lieutenant Governor's Race

Las Vegas business attorney and community leader Joseph W. Brown announced he will be a candidate for Lieutenant Governor of Nevada.

"Services as Lieutenant Governor will allow me to participate in Nevada's future, without becoming a full time politician," Brown said, adding that he believes in the citizen-legislator concept.


Since 1983 the Lieutenant Governor has chaired the State Commission on Tourism and Economic Development.

Pointing to what he called "an impending period of major growth throughout Nevada," Brown said his economic development background gives him the skills necessary to work closely with other state officials for the benefit

of Nevada's economy.

Schofield will be seeking his sixth term in the legislature.

The 55-year-old Democrat served on the Government Affairs Committee, Commerce Committee and the Environment, Natural Resource, Mining and Agriculture Committee during the 1985 legislature.

He presently is chairman of the interim committee studying hazardous materials management and is chairman of the High-Level Radioactive Waste Subcommittee of the National Council of State Governments.

Schofield said major accomplishments for the 1985 legislature included significant increases in education funding, including an engineering school for UNLV, tougher laws against drunken driving, programs to curb child abuse and increased funding for economic diversification and tourism.

He said the 1987 legislature will be challenged by significant cuts in federal funding for state programs. However, he said, Nevada must continue its efforts to improve education, create new jobs through economic diversification and expand senior citizen programs.

"The day is over," Schofield said, "when we could look to our gaming and tourism industries to provide our economic base. New, non-polluting industries must be attracted to Southern Nevada and I will support the programs and funding to make this objective a reality."

Schofield was a supporter of legislation to reduce property taxes in Paradise and Winchester Townships and was a co-sponsor of the 1985 Flood Control Act.

Schofield and his wife, Billie Lee, live at 1740 Howard Avenue. They have two children.

Brown, 44, and a Nevada resident since 1968, is a veteran of the U.S. Marine Corps. Reserve, and holds a Bachelor's Degree from the University of Virginia and a Law Degree from Washington and Lee University.

In 1981 he was appointed by President Reagan to serve as a Commissioner with the Foreign Claims Settlement Commission of the United States. His present term expires in September of this year.

He is also a former Commissioner of the Nevada Department of Wildlife, and has contributed his time to the boards of the United Way, Boys and Girls Club, Nevada Catholic Community Services, Citizens for Private Enterprise and the Las Vegas Rotary Club.
