## State Senator Nick Horn Seeks Re-Election To District 7



State Senator Nick Horn, chairman of the Senate Committee on Legislative Affairs and Operation, announced he will seek re-election representing District 7.

Horn, a 10-year veteran of the legislature, has compiled a 100 percent voting and attendance record during three terms in the Assembly, one in the Senate and two special sessions.

The 40-year-old Las Vegas democrat, has served for four years on the powerful Senate Finance Committee, which must approve all state spending. He also serves on the Interim Finance Committee.

Horn was first elected to the legislature in 1976, during which he was voted "Outstanding Freshman Assemblyman." During that session he sponsored legislation requiring state prisoners to serve more time before being eligible for parole.

In 1979 Horn was the only second-term assemblyman named to chair a standing committee, and sponsored successful legislation prohibiting sporting events from being "Blacked out" if sold out 24 hours before the event. He also sponsored nine bills to toughen criminal statutes, eight of which became law.

He served as assistant majority leader of the Assembly in 1981.

Elected to the Senate in 1982, Horn was named Outstanding Legislator by the Nevada Wildlife Conservation Federation, and sponsored legislation raising the homestead protection for homeowners to \$90,000.

During the 1985 session, Horn also served as vice chairman of the Government Affairs Committee, and co-sponsored the successful Tax Equity Bill which lowered property taxes in Paradise and Winchester Townships. He also supported successful efforts to enact flood control legislation.


"I am seeking re-election based on a record of accomplishments," Horn said. "Seniority is extremely important in the Senate, where I presently rank twelfth. There is no doubt that my seniority and experience will be important factors in my receiving the committee assignments – including the Finance Committee – which will allow me to best serve the people of District 7."

Senate District 7 is bordered by Sahara Avenue on the north, Paradise Road on the west, Russell Road on the south and Nellis Boulevard on the east.

Horn is a 15-year resident of Las Vegas. He received a doctorate degree in education from the University of Nevada, Las Vegas. He teaches business management at the Clark County Community College.

He and his wife, Nancy, live at 2543 Boise Street. They have two children.

## Supreme Court Justice John Mowbray Files For A Fourth Term In High Court



Chief Justice John Mowbray will seek a fourth term on the state's highest court.

During his judicial career, Mowbray, 67, has expedited the caseload of the Supreme Court and has brought harmony to the judicial system, creating a more effective and efficient operation.

Mowbray has presided over some of the state's most important cases over the years and has pledged to continue working for the people of the State of Nevada.

"The Supreme Court will continue to face unprecedented challenges over the next six years," he said. "We are ready to face those challenges and continue our efforts to meet the needs of the people of this state."

Responsible for both subtle and dramatic changes in the judicial system, Mowbray delivered the first ever State of the Judicial Message to the Nevada Legislature following being named Chief Justice in January, 1979.

He urged lawmakers to allow television cameras and recording devices in the court-rooms, which was overwhelmingly approved later that year.

Mowbray reorganized the court's General Legal Staff and assisted in streamlining the Supreme Court operations, saving taxpayers thousands of dollars and courtrooms, thousands of manhours.

Prior to his election to his first term on the Supreme Court in 1968, Mowbray served as a District Court Judge in Clark County.

During his term on the local bench, he was commended by New York University's American Institute of Judicial Administration for procedural reforms.

He initiated the creation of the Public Defender's Office in Clark County, a program later called "the finest in the nation."

A graduate of Western Illinois University and Notre Dame Law School, Mowbray began his legal career as chief deputy district attorney in Clark County.

Also, he was very active in the City of Hope, Las Vegas Chapter, having served as President and he was President for two terms of the National Council of Christians and Jews, and received their Certificate of Recognition.

He and his wife, Kathlyn, have four sons, John, Romy, Jerry and Terry.

Herb Tobman Files For Governor



Herb Tobman, a 35 year resident of Nevada, and a lifelong Democrat recently filed for the office of Governor.

Tobman has been in business since he arrived in Las Veags. He feels that it is time that someone with a strong business background becomes Governor of Nevada.

The Las Vegas Democrat said that if elected his major priorities will be to work toward legislation to have a lottery in Nevada, eliminate drug use in Nevada, promote tourism and oppose any legislation that will increase gaming taxes. He will work toward a decrease in hospital costs in Nevada which now average \$941 per day as compared to a national average of \$451 per day. His overall goal will be to develop a businesslike working system for Nevada rather than a bureaucratic one.

Tobman's feelings on these issues are that a lottery will not detract from gaming revenue, but will add immensely to the State's income. He proposes that the money earned from the lottery be used for education and senior citizens. He advocates drastic measures such as life imprisonment for those convicted of selling drugs, and life imprisonment without the possibility of parole for those who sell drugs to minors. Since tourism is the largest source of revenue for the State, Tobman stresses the importance of bringing more tourists into Nevada thus automatically increasing the state's income from sales and gaming taxes and boosting the economy in general.

The facilities at the Tobman for Governor Campaign headquarters at 830 South Main in Las Vegas are available to all Democratic candidates who do not have their own headquarters. Tobman thinks that more qualified and politically astute people would run for public office if they could afford office space and personnel to run it. The offer was extended by Tobman to encourage Democrats who can be of benefit to the community and state to seek public office.

Tobman has been active in local, state and national politics since his arrival in Nevada. He served on the first Las Vegas Recreation Board and the Clark County Planning Commission. He was a board member of the Las Vegas Convention Authority representing the hotel industry.

Tobman feels that someone who deals on a daily basis with personnel, payroll and the economic climate of Nevada can best understand the intricacies of running the State which is, after all, a multi-million dollar business and should be treated as such. "I believe that many years as a successful businessman and my continued interest and thorough knowledge of the political structure of Nevada qualifies me to be a highly productive Governor," stated Tobman.

Tobman and his wife, Jean, have four children and seven grandchildren, all of whom are native

Nevadans.
