Assemblywoman Myrna Williams Seeks Re-Election To District 10



Assemblywoman Myrna Williams, author of the Assembly resolution opposing location of a high-level nuclear dump-site in Southern Nevada, announced she will seek re-election representing Assembly District 10.

The Las Vegas Democrat said that if reelected, "my first act in the 1987 legislature will be to again introduce a resolution opposing the dumpsite."

Williams said major accomplishments of the 1985 legislature included "our successful efforts to secure an engineering school at UNLV and additional funding for tourism and economic development."

A co-sponsor of the Flood Control Act, she said, "I am looking foward to the time when we no longer have to fear that there will be deaths and enormous property damage every time there is any significant rainfall in Clark County."

During the 1985 legislative session Williams supported the Tax Equity Bill for Paradise and Winchester Townships, tougher penalties for drunken drivers, stronger laws on crimes against the elderly, penalties for deceptive trade practices and legislation allowing workers to include tip income in the calculation of injured worker benefits.

Williams was the only Clark County member of the Assembly to serve on four committees during the 1985 session. She served on the Judiciary Committee, Commerce Committee, Taxation Committee and Labor and Management Committee.

Assemblyman Terry Tebbs Seeks Re-Election

Assemblyman Terry Tebbs announced he will seek re-election representing District 42.

During the 1985 session of the legislature, Tebbs was the only freshman to serve on the powerful Ways and Means Committee which approves all state spending programs.

Tebbs said his service on the Ways and Means Committee "was an invaluable experience in learning the fiscal needs of all state departments and agencies. We were able to set priorities, live within our means and still meet the needs of people."

The 28-year-old Republican also served on the Commerce Committee and the Economic Development and Tourism Committee. He compiled a 100 percent voting and attendance record during his first term in the legislature.

He said priorities in 1987 will include "continued work for quality education, expanded tourism and economic development programs and thoroughly reviewing the recommendations of the interim study committee on health care costs."

A member of the Interim Study Committee on Prison Site Selection and Advance Planning, Tebbs said the committee will recommend the locations of two new prisons to be constructed in the next five years and prepare advance plans for the new prisons. The recommendations will be submitted to the 1987 legislature.

Jack Jeffrey Seeks Re-Election To Assembly District 22



Jack Jeffrey, a 12-year veteran of the Nevada Assembly, announced he will seek re-election to a seventh term as representative of District 22.

The district includes portions of Henderson, all of Boulder City, Searchlight, Nelson and Laughlin.

The 47-year-old Henderson Democrat, who served as assistant minority leader during the 1985 legislative session, said priorities of the 1987 session will include "continued efforts to increase the quality of education, economic diversification and fiscal integrity and responsibility."

Jeffrey is the fourth most senior member of the Assembly. He compiled a 100 percent voting and attendance record last session and has been present for 5,284 of 5,287 votes during six regular and two special sessions of the legislature.

Jeffrey served in two sessions as chairman of the Commerce Committee and was majority leader in 1983.

He has authored successful legislation to expand the Public Service Commission from three to five members and supported legislation increasing penalties for crimes against the elderly, tougher child pornography laws and punishment for participation in criminal syndicates. He also supported expanded programs for tourism and economic development.

Jeffrey was chairman of the subcommittee which developed Nevada's strong fire safety and retrofitting law during the 1981 session following the fires at the MGM and Hilton Hotels.

During the 1979 session, Jeffrey was successful in efforts to secure \$1.9 million for the Henderson Community College.

He also supported repeal of the sales tax on

She compiled a 100 per cent voting and attendance record.

She presently is serving on interim legislative committees studying Nevada malpractice insurance problems and community service block grants. She also is on the Governor's Commission on Child Support Enforcement, and serves as southern Nevada chairman of the commission.

Williams said major issues facing the next legislature will include "holding the line on spending, continued emphasis on the state's education programs, tougher laws dealing with child support and the problems of state prison policy.

Williams, a 22-year resident of District 10, received degrees in law enforcement and social services from UNLV and has an extensive background in volunteer and professional work in allied fields. She served on the executive board of the Nevada Humanities Committee.

She has served as president of the Clark County Women's Democratic Club and filed the historic lawsuit which led to greater Clark County representation on the University of Nevada Board of Regents.

Williams and her husband David live at 3441 Sioux Way. They have one child and one grandchild. Aid to Families with Dependent Children.

During the 1985 session, Tebbs was cosponsor of succesful legislation to bring murder charges against drug dealers if a death results from sale of controlled substances.

He also supported the Flood Control Bill and backed the Paradise-Winchester Tax Equity Bill which has resulted in a lowering of property taxes in Paradise and Winchester Townships.

He also supported tougher penalties for drunken drivers, stronger laws on crimes against the elderly and legislation allowing workers to include "tip income" in the calculation of injured worker benefits.

Tebbs was active in co-sponsoring legislation to curb child abuse, including requirements for fingerprinting and investigation of any person providing care for children; increased penalties for possession of child pornography; and a resolution encouraging the Supreme Court to provide for videotaping testimony of abused children.

Tebbs and his wife Dana live at 3834 Don Carlos Street. They have two children.

District 42 is bounded by Tropicana Avenue on the south, Nellis Boulevard on the east, Charleston Boulevard on the north and Eastern Avenue on the west. food and the personal property tax, and is a longtime opponent of any legislation which would consolidate local governments without a vote of the people.

Presently he serves on the Interim Committee on Prison industries and the interim committee studying the issue of high level nuclear waste.

A member of the Ways and Means Committee, which passes final judgement on all state expenditures, Jeffrey also serves on the Interim Finance Committee.

He recently was nominated by the Nevada Development Authority and appointed by the Board of Clark County Commissioners to the committee on the Overall Economic Development Plan of Clark County. He also was recently appointed by the State Board of Education to the Technical Skills Committee, is a trustee of the Nevada Council on Economic Education and a cabinet member of United Way.

Jeffrey is a former Henderson city councilman and mayor pro-tem. He served on the St. Rose de Lima Hospital Board, Eldorado Valley Advisory Group, Regional Streets and Highways Commission and the Las Vegas Convention and Visitors Authority.

Jeffrey and his wife, Betty, live at 340 Chaparral Drive. They have three children.
