RENO - Assemblyman David Humke announced he will seek a third term representing Southeast Reno and Washoe County's District 26 in the Nevada legislature.

"I've been able to accomplish a great deal in the past two terms," Humke said. "But there's more work to be done."

Humke said fiscal questions will dominate the 1987 Legislative Session. "The next session needs to address the growing problems of liability insurance and health care cost containment," he said. "We're also going to have to take a look at the financial health of our prison system and the whole prison industries program."

The 37-year-old Republican highlighted his legislative experience, pointing to his success in strengthening Nevada's protection of children's rights, setting unified standards for determining

## Eileen Brookman Seeks Election District 9



Former six-term assemblyman Eileen Brookman ended a voluntary retirement from politics by filing for election to the assembly representing District 9.

Brookman served 14 years in the Assembly from 1965 to 1979. She also served in one special session of the legislature.

The veteran Las Vegas Democrat served on most of the important Assembly committees during 14 years in the legislature. She was vice chairman of the Ways and Means Committee and served on the Government Affairs Committee.

Brookman said she was re-entering political life "to work on tremendous problems and challenges facing Nevada in the mid 1980's."

She said the 1987 legislature "must work for quality education at every level, greater funding for economic diversification and tourism programs, senior citizen programs and more assistance for the handicapped."

Brookman was named "Outstanding Woman of the West" and recognized as one of the 2,000 women of achievement in the United States. She also received the Clark County Achievement Award on behalf of senior citizens.

During her legislative service, Brookman was the sponsor of the Older Americans Act which brought back to Nevada funding necessary for senior citizen benefits, reduced transportation fares and created the State Division of Aging Services, including the "Meals on Wheels," program.

She has been married to local contractor George Brookman for 45 years. They reside at 1900 Cochran Street and have two children.

There is no incumbent for the District 9 seat. The present incumbent, Bob Coffin, is seeking election to the State Senate.
