## Mowbray And Springer Joint Filing

As the Supreme courts senior member, Chief Justice Mowbray has served on the high court since 1967, and in the Nevada judiciary since 1959. Vice-Chief Justice Springer, formerly Nevada's Attorney General, won election to the Supreme Court in 1980.
