### Former Model/Actress Files For State Seat



LAS VEGAS, NEVADA — Former model/actress Barbara Holly Jones has filed her candidacy for a seat in the Nevada Legislature.

Jones, who served on behalf of many community activities while she was busy with her acting career, moved to Las Vegas 12 years ago from Hollywood, California, to find a place which she could call her own and get involved in political issues.

A strong civil rights advocate, Jones feels that everyone must "protect the rights of each citizen of Nevada in their pursuit of life, liberty and happiness." She's also a strong supporter of flood control and one of her goals is to see that the necessary steps are taken to prevent the loss of life and property.

Improving the quality of our schools and making sure that these schools are also built safely and effectively is one of her most vigorous issues.

The statuesque and very eloquent and candid blonde was featured in different roles in movies, the theatre and on TV. When in Los Angeles, she was a member of the P.T.A., secured the Del Mar Beach Club in Venice, Cal., and promoted the original drug rehabilitation center, Synanon.

Her other proposals include a bill on economic survival, mass rapid transit and, in general, to protect the innocent citizens from abuses.

Former Assemblyman and Clark County Commissioner Paul May, an 18-year veteran of the Nevada legislature, announced he will seek election to the assembly representing District 19.

May served in nine regular sessions of the legislature and three special sessions until his appointment to the board of county com-

#### Bill Kissam Seeks Assembly District 4

Former assemblyman Bill Kissam announced he will seek election to the Assembly District 4 position he held from 1976 to 1978.

The seat is being vacated by Assemblyman Mike Malone, who is seeking election to the state Senate.

During his service in the Assembly, Kissam supported the open meeting law, legislation making child abuse a felony, stricter gaming control laws and tougher criminal laws for crimes against senior citizens.

Kissam, a Democrat, has served on the Education Committee, Health and Welfare Committee and the Environment and Public Resources Committees. He also served on the State Obscenity Laws.

If returned to the legislature, Kissam said he would work for "improved education programs at every level, programs to increase economic diversification and development and for more meaningful programs for our senior citizens."

Kissan has been a member of the Southern Nevada Advisory Committee to the Division of Aging Services since 1978. He was appointed by Gov. Mike O'Callaghan and re-appointed by Gov. Roberat List and Gov. Richard Bryan. The committee established priorities of senior citizen needs to present to the legislature.

He was on the board of directors of Aid to Adoption of Special Kids, and was personally responsible for a bill allowing the publication of pictures of certain children known as "Tuesday, Wednesday and Thursday's Child" on local television stations and in local newspapers.

He is a member and past chairman of Seniors United, and serves on the Clark County Committee on Aging. He also served on the Clark County Coalition Health Systems Agency as a representative of senior citizens.

Kissam compiled a 100 percent voting and attendance record during his term in the Assembly.

He is a 33-year resident of Las Vegas and is a real estate broker and developer. He was graduated from UNLV with a degree in business administration, and served in the U.S. Navy.

Kissam, 58, and his wife Margie reside at 1340 Scenic Way. They have four children.

missioners by Governor Richard Bryan in 1984.

In 1979 May was elected speaker of the assembly -- the highest leadership position in the assembly. He also served as speaker during the 1980 special session of the legislature.

The 58-year-old Democrat was appointed to fill a vacancy on the North Las Vegas City Council in 1985. He did not seek election to the position when his term expired.

May served as chairman of the Assembly Taxation Committee in 1973, 1975, 1977, 1981 and 1983.

He also served as vice chairman of the Government Affairs Committee and on the Labor and Management Committee, Fish and Game Committee, Judiciary Committee, Natural Resources Committee and the Legislative Functions Committee.

During his service in the legislature, May sponsored successful legislation to locate the Clark County Community College in North Las Vegas and to annex Rancho High School to North Las Vegas. He has opposed efforts to consolidate North Las Vegas government with the city of Las Vegas.

May said challenges facing the 1987 legislature include "adequate support for quality education, continued efforts for economic diversification, transportation and roads, and preparation for a possible threat to our revenues based on cutbacks in federal support for state programs."

May said other issues include state policy on nuclear waste disposal and "work to meet the needs of the state without increasing the tax burden on individuals."

May and his wife Lucille live at 3309 Wright Avenue. They have three children.

# Assemblyman Danny Thompson Seeks Re-Election

Assemblyman Danny Thompson, co-sponsor of the 1985 Flood Control Bill, announced he will seek re-election representing District 21.

Thompson has served in the legislature for six years. During three regular sessions and one special session, Thompson has compiled a 100 percent attendance and voting record. He has voted on 2,652 consecutive bills and resolutions.

District 21 encompasses Overton, Logandale, Bunkerville, Mesquite, Green Valley and most of Henderson.

During the 1985 legislature, Thompson served on the Government Affairs Committee, Commerce Committee and the Labor and Management Committee. He also served one month on the Ways and Means Committee, replacing a colleague who was in ill health.

In his three terms, the 34-year-old Henderson Democrat has also served on the Judiciary Committee and the Transportation Committee.

He presently is vice chairman of the oversight committee responsible for monitoring activities of the Clark County Flood Control District.

Thompson also serves on the Legislative Commission and Security and Services Committee of the National Conference of State Legislators.

"The floor control bill was one of our major accomplishments of the 1985 legislature," Thompson said. "I know we all look forward to the day when we no longer have to fear that there will be deaths and enormous property damage anytime there is significant rainfall in Clark County."

Thompson said major challenges in 1987 "include continued efforts to improve the quality of education at every level, expanding programs for economic development and ongoing efforts to control the costs of health care."

Thompson has supported tougher penalties for drunken drivers, stronger laws on crimes against the elderly, penalties for deceptive trade practices and legislation allowing workers to include "tip income" in the calculation of injured worker benefits.

Thompson and his wife Debbie live at 226 Navajo Drive. They have two sons.
