Jerry Watson Says, "Help Me Abolish The Office Of Public Administrator!"



Jerry D. Watson, a local real estate broker, tax practitioner, business consultant, and VA/HUD Property Management Broker, has filed for the position of Clark County Public Administrator. He feels that his many years of experience in estate planning, appraisal, insurance, and property management make him the best candidate for this position.

The Public Administrator is responsible for settling the estates of those who die in the County without leaving a will, have no heirs, or who do not have relatives willing to administer the estate. He also acts as the Public Guardian and can be assigned to administer the affairs of people who are unable to do so. He receives referrals from various Social Service Departments recommending public guardianship for adult wards over the age of sixty (60), and services required on cases with insufficient resources for private burial.

Jerry D. Watson advocates that everyone have a valid will prepared in order to avoid becoming a statistic in the Public Administrator's office. The taxpayers of Clark County should be made aware of the unnecessary costs arising to themselves and to the County through the lack of wills. The Senior Law Project (grant funded), which assists seniors in drafting wills, is one concerned group taking action to inform and service the public.

The Public Administrator coordinates with relatives of the deceased, attorneys, the Probate Court, and various agencies. Public education on the necessity of a will could help reduce the caseload and expedite services to those who would still be affected by this office.
