

**Dr. Leonard Kreisler -

Dr. Leonard Kreisler, Medical Director for Reynolds Electrical and Engineering Company, has filed for election as Clark County Commissioner, District E.

Dr. Kreisler was born in Brooklyn, New York in 1930 and grew up in White Plains, New York. He received his Bachelors Degree in Science at Allegheny College, Pennsylvania in 1952; Phi Beta Kappa, cum laude. He received his Medical Degree in 1957 from the University of Vermont College of Medicine. It was in Vermont that Dr. Kreisler met Joan Dorfman in the undergraduate school, and they were married in 1957. After internship he spent two years in the Army Medical Corps doing special work with the Walter Reed Army Unit at Ft. Detrick, Maryland. The Kreislers then spent thirteen years in Peekskill, New York where Len practiced as an "old fashioned" family practitioner delivering babies, setting bones, and even making house calls. After coming to Las Vegas in 1973 with Joan and the three children, Kevin, Kay and Kenneth, he decided to fill in some of his new found spare time by serving on the Board of Temple Beth Sholom from 1975 to 1980, and First Vice President 1978-1979. He is Board Certified in Family Medicine and is also the only M.D. certified in Occupational Medicine in the State of Nevada. **Paul Fisher, A Fighter
For Fourth Amendment Rights**

In 1953, Paul C. Fisher found himself embroiled in a legal battle with the Wage and Hour Division of the Department of Labor. He resisted what the Labor Department called a routine search of his proprietorship books and records because, as the Labor Department admitted, there was no probable cause as required by the Fourth Amendment.

"If you convict me for contempt of court for resisting your illegal order, I must obey or accept the punishment. I have chosen to accept the punishment because I believe that this court and the Labor Department are misusing their power and that my conviction will eventually win a victory for the cause of freedom," Fisher told the court.

Fisher went so far as to spend 12 days in jail to illustrate his commitment to protecting our



manages a budget of three million dollars annually for the medical program.

In addition to the many boards and foundations he is particularly proud of his accomplishments in establishing the University Medical Center Foundation; a non-profit group that aims to enhance the delivery of quality medical care at our only not-for-profit teaching hospital in Southern Nevada. In addition he can bring other talents to the Commission: Having grown up with a father who was a carpenter/contractor for over fifty years, he has an understanding of the construction industry, and as a first generation American, son of an orphaned twelve-year-old immigrant, he strongly believes in education, hard work, the dignity of labor and the will to fight for what's right. His primary commitment is to get the maximum return on the tax dollar in all areas of County Government.

rights under the constitution. He received national publicity, nearly all favorable, and his company sales increased dramatically.

In spite of his protest, the business books were opened and the audit was made. But no violations were found and Fisher was exonerated on all charges by Federal Judge Michael L. Igoe who remarked, "There is nothing about you or your reputation which indicated you are not an upstanding and outstanding citizen and a very decent one at that."

Fisher has long been a crusader for individual rights and less government control as he believes was the intent of the founding fathers and the constitution. Like Paul Fisher, Ralph Nader was once a single voice crying out in the wilderness for what he believed were the rights of all Americans. Fisher hopes that if enough people hear his message, they will see the merit in his tax reform plan and his proposed constitutional amendment. He is now a candidate for the First Congressional District in Southern Nevada in order to help bring his common sense plan to the attention of the American people.
