dealings with the Clerk's office has given me a great deal of insight as to what needs to be done to provide quick, efficient service. And, how to provide that service not only to attorneys and those in the legal profession, but to the general public as well," Dischel explained.

The County Clerk's office is responsible for filing all documents in the Eighth Judicial District Court of Clark County.

Modernizing the existing computer system is a must, according to Dischel. "The computer system in the Clerk's office doesn't interface with other county and city entities, which means Henderson and outlying areas have to hand carry their documents in for filing." Document filing and retrieval is still done manually by the staff, resulting in long delays and waits for official paperwork. "Our court system is backlogged enough without having our judges going into court without filed documents, and sometimes without even the official court file on the case," she said.

The County Clerk's office is also responsible for payment of jury fees and disbursing federally mandated child support payments. "Here again, proper modernization of office procedures could save not only time, but taxpayer's money," Dischel explained. "Checks from the Clerk's office are handwritten. If you tried to run a private business the size of the County Clerk's office, and handwrote every check, you'd probably be out of business." Dischel is a firm believer in applying established business procedures to public office.

One important step toward making the Clerk's office more responsive to the public is establishing a central information center, an idea Dischel believes will shorten lines and save time. Providing certain information over the telephone, a convenience not presently available, is another way Dischel plans to improve service.
