**AFL-CIO President
Presses U.S.S.R.:
"Stop Your War Against
The Soviet Jews"**

Declaring that "there can be no trust between our nation and a nation which keeps 400,000 Jews locked in," AFL-CIO President Lane Kirkland recently urged the Soviet Union to cease its "war against the Soviet Jews" and to "let the Jewish people go."

Kirkland's statements came at an emergency meeting of the National Conference on Soviet Jewry, called to assess the "mini-summit" in Reykjavik, Iceland, between President Reagan and Mikhail Gorbachev.

"We are here," Kirkland said, "to join our voices in a loud chorus of support for Jewish 'refuseniks' and the heroic leaders of the Soviet human rights and independent trade union movements. We are here to say to Ida Nudel,

Vladimir Slepak, Yosif Begun and to all Soviet Jews: you do not stand alone. Standing with you are millions of men and women in the Western democracies and particularly in the United States. Standing with you is an American trade union movement which believes that the cause of peace cannot be separated from the cause of freedom."

The AFL-CIO has long fought for the rights of Soviet Jews to emigrate or to live fully Jewish lives in the U.S.S.R. The labor federation is a strong supporter of human rights causes around the world, and has supported the Soviet Jewry movement since its early days in the 1960's.

Kirkland concluded, "Your own movement, which so ably and steadfastly defends Soviet Jewry, must carry on that noble struggle. The AFL-CIO stands with you and your brethren. We stand with you in your 'Campaign to Summit II.' And we will stand with you until Yosif Begun, Andrei Sakharov and Anatoly Marchenko and all defenders of human rights are set free."
