### B'nai B'rith Canada Oposes **Nation's New Immigration Policy**

TORONTO (JTA) - human rights." B'nai B'rith Canada (BBC) is concerned that the government's new policy on refugees will prevent bona fide refugees from receiving sanctuary here.

Canada no longer will allow new arrivals to immediately claim refugee status if a third country will accept them, and some recent refugees may be sent to third countries until Canada rules on their status.

"We do not believe the Canadian public is hostile to refugees," commented Marilyn Wainberg, chairman of BBC's Institute for Governmental and International Affairs. "In its formulation of a national refugee policy, the government should confuse widespread desire to control abuse with a minority desire to deny access to legitimate refugees.

"The challenge facing the government is to develop a refugee policy which is both responsible in that it can control abuse; and humanitarian, in that it respects the fundamental principles of Las Vegas Israelite

# Judge Earle W. White Selected For Conference In Israel

Judge Earle W. White, Jr., Chief Judge of Clark County's Eighth Judicial District Court, has been selected for the Project Interchange Leadership Conference in Israel, March 24 to April 2nd. The conference is sponsored by the America-Israel Friendship League and the Jerusalem Institute for Israel Studies in order to increase the knowledge of American leaders regarding U.S.-Israel relations.

Judge White will experience Israel first-hand through both seminars and tours of various parts of Israel. He will arrive in Tel Aviv on the 24th and will tour and meet with the Mayor of Tel Aviv-Jaffa, the Mayor of Hatikva Quarter and journalists and then dine with a Bedouin family in their tent.

From Tel Aviv the tour will take Judge White to the Dead Sea and Jerusalem for talks. After Jerusalem he will proceed to the West Bank and Bethlehem for meetings with the Mayor of the West Bank, journalists and Hebrew University professors. Following those meetings will be discussions with David Kimchi, former Director-General of the Israel Foreign Ministry and a visit

said.

"We've made a lot of progress. We've interviewed the central characters in this matater and will have completed taking our evidence within seven to 10 days," Eban said. He said about a dozen witnesses have been heard, on the political and operational levels.

They included the two top Israeli officials linked to Pollard, Air Force Col. Aviem Sella and former Mossad operative Rafael Eitan.

The latest was Avraham Shalom, former head of Shin Bet, Israel's internal secret service agency, who appeared before the subcommittee. Shalom conducted the first investigations when the Pollard spy case came to light in 1985.

Meanwhile, some concern was expressed here over an anomalous situation that may arise if the Knesset body issues its report while the Cabinetappointed inquiry is still at work hearing testimony, examining documents and analyzing its findings.


