TEL AVIV (JTA) -The trial of alleged war criminal John Demjaniuk continued Jerusalem district Court with the crossexamination of Helge Grabitz, a member of the district attorney's office in Hamburg who specializes in the prosecution of Nazi war criminals.

Israel announced last week that it would phase out its military and other relationships with South Africa.


