Miami Home Asks For Jewish Thrift Shop By Any Other Name

WEST PALM BEACH. Fla. (JTA) - When is a Jewish thrift shop not "The Jewish Thrift Shop?"

A U.S. District Court in Fort Lauderdale may have to decide that

very question, following a suit filed by the Miami Jewish Home and Hospital for the Aged against a competing thrift shop operator.

The Palm Beach Jewish World reports that the Miami home is trying to stop the owner of Thrift Shops of West Broward Inc. from using the name "The Jewish Thrift Shop" for its shop in Hallandale.

The West Broward Organization opened that shop in 1986 at the former site of the Miami home's thrift shop, which moved less than two miles away. The organization operates a second shop in West Palm Beach called "The Jewish Thrift Shop."

The Miami home alleges that the West Broward organization is making people believe that "The Jewish Thrift Shop" is still operated by the Miami home, which calls its own thrift shop "Douglas Gardens Thrift Shops," "Miami Jewish Home and Hospital for the Aged Thrift Shops" and "Jewish Home Thrift Shop" in its advertising.

The home is seeking a permanent injunction against organization
