Opus Dance Ensemble Will Present "Pastiche" April 16



The Opus Dance Ensemble of Las Vegas will present its fourth concert, Saturday, April 16, at 2 p.m. in the Tropicana Hotel's Tiffany Theatre. The concert, entitled "Opus Pastiche" - a little bit of this and that - will feature an all-new repertoire by Opus' professional showroom dancers and will highlight contributions from local guest choreographers.

Tickets are \$8 in advance and \$10 at the door and are available at Bullocks, (Fashion Show Mall), The Upper Ear (3900 W. Charleston), and The Tinder Box (Boulevard Mall) or by calling 732-9646.

The program will open with excerpts from the classic ballet, "The Sleeping Beauty" by Tchaikovsky. Solo variations will feature Silver, Topaz and Lilac Fairies. Also included will be the character variation, Puss & Boots, as well as the famed Bluebird Pas de Deaux. Original choreography by Pepita has been restaged by Opus Artistic Director, McGarry Caven.

A contrasting contemporary jazz piece will be choreographed and performed by dancer Linda Bernabel, currently appearing in "Splash" at the

Riviera Hotel. This dynamic work, entitled "One of My Kind," will be set in a subway station and will feature Bernabel along with guest artists Steven "Sugarpop" DeSilva and Jason DeSilva. New. wave and rock music will accompany this explosive street dance sequence.

The program will then take on a more serious tone with the ballet, "The Beloved." It tells the story of a young newly married couple and an unfortunate accident, which leads to a pas de deux with the grief-stricken husband and his young, deceased wife. Music is by Debussy; choreography by McGarry Caven.

Other works to be presented in the upcoming concert will include "Little Wheel Spin and Spin," choreographed by Winston Dewitt Hemsley to the music of Buffy Sainte-Marie, and "The Dying Swan" by Saint-Saens, performed by Lesley Bandy.

Utilizing the entire Opus company of 15 dancers and closing the performance will be the final dance sequence from Gershwin's "An American in Paris." McGarry Caben will rechoreograph this work, which has been identified as a film classic throughout the past three decades.

The Opus Dancers originally performed locally in the early hours of the morning following their nightly "Strip" shows. A group of businesspersons led by Jodi Warman, Opus president, was instrumental in assisting the dancers make the transition from nightclub to stage.

GENEVA (JTA) — The final phase of the arbitration process that will determine ownership of 14 disputed sites along the Israeli-Sinai border, including the half-square-mile Taba resort area on the Red Sea, opened here recently.

The preliminary session was brief. Israel displayed a videotape film of the Taba area. There was a short procedural discussion after which the meeting was adjourned to reconvene again.

Egypt will present its case for the next three days, and after a three-day interval, the Israelis will present theirs, which is expected to last four days. Both sides will present witnesses. Their names have not yet been released to the press.

Israel and Egypt will both present visual arguments, including slides, maps and, in Israel's case, a plaster scale model of the Taba area.
