SEARCHLIGHT

(Special Correspondence)

The activity here at this time of the year is unprecedented. More sales, transfers and bonds have been consummated within the past month than at any time within the past year. At present 130 stamps are dropping daily, seven mines producing and thirty-one mines developing their holdings.

The shaft of the Cyrus Noble mine is being sunk to the 500-foot level and is now down 455 feet.

The Sunny Jim group, situated three miles northeast of Searchlight is being developed by Kennedy & Freeman.

Two important discoveries of ore have been made within the past week on the Buster Brown and Esmeralda claims of the El Dorado Canyon Mining and Milling Co.'s estate in El Dorado canyon. Five assays were made from the ledge and the returns were as follows: \$35.50, \$24.00, \$21.70, \$12.30 and \$4.40. A ten-inch streak next to the hanging wall runs into the hundreds and was not included in the assays.

The Cyrus Noble Extension shaft has reached the 100-foot level and the company will at once begin drifting and crosscutting to determine the extent and value of the vein.

CLARK AND SEARCHLIGHT

In the Denver Mining Record Dr. J. K. W. Bracken denies the recent report that he was investigating properties in El Dorado canyon for Senator Clark and that the latter was contemplating investments in the Searchlight district.

Mr. Bracken states that a few years ago the Clark interests made some investigation of the camp and turned it down, and that anyway such men as Senator Clark are not in the habit of publishing beforehand their contemplated investments.

FURNACE CREEK

Copper Deposits Attracting Attention

Salt Lake Tribune says: The wonderful copper deposits of the Furnace Creek mining district, located about 75 miles south of Bullfrog, which has succeeded in attracting such mining talent as Senator Clark, Charles M. Schwab, F. Augustus Heinze and many others of prominence in the copper field, bid fair to call upon Salt Lake City to have its resources opened up. Rumors from the south has it that Samuel Newhouse is either a hearty convert to the copper possibilities of Furnace Creek, or will be just as soon as time will permit.

Furnace Creek came into prominence the first of the present year, through the extensive preparation made by Patsy Clark to enter this heretofore forbidden region for the purpose of developing what was termed the greatest surface proposition ever enjoyed by the red metal seekers. During the past seven or eight days there have been at least ten big sales made of these copper properties, the buyers representing some of the largest copper operators in the country.

The district within which the main excitement centers is about 20 miles from the railroad which Borax Smith is rushing into the Bullfrog district. But the report has it that Senator Clark is preparing to run his line into the heart of the district, and attach to the terminal thereof a smelter of sufficient proportions to handle the reasonable output of the mines during the initial years of their activity.

BONDS FOR \$400,000

A. D. Nash, of Tonopah, and Edgar Wallace, of New York, have bonded claims in the Furnace Creek district to the extent of \$400,000, and have made several big payments. Operations on four groups will be commenced at once under the management of K. J. Donnelly, whose claims were among those bonded.

Mr. Donnelly has been in Las Vegas this week procuring tents, timber and supplies to establish a working camp. Development will proceed regardless of the hot weather.

PATSY CLARK INTERESTS

A. L. Koupfand has arrived from Butte, Montana, to relieve Patsy Clark's manager, J. P. Harvey, who will go to Spokane for a couple of month's vacation.

Work on the Clark mine is being pushed with three shifts, and a power hoist.

JOHNNIE MINES

A communication from Johnnie says: The good values obtained in the Minnie Mac lease of the Johnnie Consolidated Gold Mining Company has created considerable activity on leased ground in this camp and contracts are frequently drawn. Negotiations are under way for the erection of a custom mill, and in less than 60 days the drop of the stamps will be resounding throughout the district.

CLARK ROADS

Claims Control Will Go After Business

While in Goldfield the other day Senator Clark stated to the newspaper men that he will positively build the Las Vegas road through to Goldfield.

"My surveying corps is 31 miles out of Bullfrog on the survey," he said, "and the next time I come into Goldfield I expect it will be over my own line."

"The San Pedro road has been a success beyond expectations, and I will build feeders to that road wherever there is business to justify it."

CONTROLS SALT LAKE

At Rhyolite Senator Clark gave out the following:

"I desire to state that the report relative to E. H. Harriman owning the control of the San Pedro, Salt Lake and Los Angeles railroad is absolutely without foundation of fact. I own the control individually, and always have done so."

"There has been no change whatever in the management, and moreover the branch from Las Vegas to Tonopah, which will maintain a separate corporate existence, also is my individual enterprise, barring a small stock allotment among my friends. The branch will be completed as speedily as possible."

"We have been held up in our tie shipments on account of sailors' and longshoremen's strike on the coast. We are in a position to finish the road to Bullfrog within ten days on the delivery of our ties."

"The report of a consolidation of the Goldfield-Bullfrog railroad and of the Las Vegas-Tonopah road is without foundation."

PIOCHE RAILROAD

Clark Will Decide After Present Trip

The Age is advised that Senator Clark and Wm. McDermott, manager of the United Verde mine, went from Las Vegas to Pioche to personally investigate the mining possibilities of that camp. Upon the result of this investigation will rest Senator Clark's decision whether he will build the Pioche branch from Caliente.

Mr. McDermott arrived in Las Vegas Tuesday to join the Senator upon his arrival from the Bullfrog district. They went north together Tuesday evening. It is understood that Clark sent for McDermott to assist him in sizing up the situation at Pioche.

In case the road is built to Pioche it will no doubt be continued on to Elko, the big copper camp in White Pine county.

All this territory would send ore to a smelter at Las Vegas.

Senator Clark and party came to Las Vegas over the new road Tuesday evening and proceeded east on the Salt Lake, without stopping for friendly calls here.
