The measure is sponsored by the Nevada Commercial League, and has been prepared by Senator Boyd in conjunction with members of the league and consulting attorneys. It provides for a commission to be appointed by a board consisting of the governor, lieutenant governor and attorney general. The power of removal is vested in the governor. A general canvass of both houses indicates the passage of the bill.

Section 7 of the bill provides that Western Classification No. 41 shall be the accepted classification and establishes the following maximum rates for each ton per mile on standard guage roads:

Class 1-Eight cents a ton a mile. Class 2-Seven and four-tenths cents

a ton a mile.

Class 3-Six and four-tenths cents a ton a mile.

Class 4-Five and two-tenths cents a ton a mile.

Class 5-Four and six-tenths cents a ton a mile.

Class A-Four and six-tenths cents a ton a mile.

Class B-Three and six-tenths cents a ton a mile.

Class C-Three and one-tenth cents a ton a mile.

Class D-Two and seven-tenths cents a ton a mile.

Class E-Two and seven-tenths cents Speaker Skaggs wants it passed and a ton a mile.

All other property classed higher than class one and known as class one and a half times first class, double first class, three times first class and four times first class, shall not exceed twenty cents a ton a mile. Further, the maximum charges on fluxes and ores are pose of selling worthless mining stock. set as follows:

Ores for fluxing, 1-2 cent a ton a mile: ores not exceeding \$20 in value, 3-4 cents a mile; ore not exceeding \$30 in value, 7-6 cents a mile; not exceeding \$40, 1 cent a mile; all other ores not greater than 1.1-2 cents the mile.

Save Salton Sea

An assembly and joint concurrent gesolution has been introduced by Mr. Williams of Lincoln, memorializing President Roosevelt and congress to desist from any further attempts to check the flow of the Colorado river into Salton sea.

It is believed that if the sea is allowed to remain in the state caused by the broken banks of the Colorado the rains next summer will increase to such an extent that a great agricultural region will be developed there.

Anti Pass Bill Vetoed Governor Sparks has vetoed the antipass bill which was passed by big majorities in both senate and assembly. It is not thought it will be passed over the veto, but another bill will be prepared.

Vaughan's Opinion

Assemblyman Vaughan of Lincoln in discussing the proposed railroad commission said to the Reno Gazette:

"I have lived in California, where the commission is elected by the people, and the railroads nominate and elect the members, and it is nothing but a farce. We must, however, have some remedy and I am willing to support any bill that promises relief."
