## GREAT POTOSI MINES

### Shipping 1,000 Tons Per Month of Lead and Zinc Ore

### VALUES FROM \$25.00 TO \$65.00 PER TON

The following unfair and misleading article was published in the Los Angeles Times, March 7th:

#### FALSE REPORT

"J. S. Wiley, who has been hauling ore and supplies at the mines; around Las Vegas, is in the city, and states that the famous Potosi mine at Arden, ten miles from Las Vegas, is rapidly 'pinching out.' In the past it has shipped as high as 35 tons a day, and now it is producing only about 12 tons. The Potosi is one of the famous mines worked first by the Mormons in 1862. It is a silver and lead producer and has a blanket formation. It has been mostly gophered, and the depth cannot be learned at this time. The news will be received with regret by mining men, especially interested in that region, but the record of forty years is not calculated to discourage others. The pinching out' has been going on for some time. The mine is owned by W. H. Coffin of Duluth, Minn., and J. N. McDonald.

The Age has watched the Potosi mine shipping out rich lead and zinc ore, at the rate of 1000 tons per month, for the past year, and wishes all other mines would "pinch out" in the same way.

Mr. Wiley evidently does not know much about the mine. It is not a "silver and lead producer," as he says, but regularly ships galena or lead ore worth \$65.00 per ton, and zine ore averaging about \$25.00 per ton. The silver and copper values are lost in the treatment of

The manager of the Potosi Lead Mining Co. does not feel it necessary to answer newspaper reports that may be printed through malice or error. However, The Age, desirous of printing the truth, has made inquiry of well-informed persons connected with the Potosi mine officially and financially. They state that Mr. Wiley was a teamster, had trouble with the Potosi company and got even by giving out the above report; that Wiley knows nothing about the mine workings. C. V. Smith, son of Manager Wm. E. Smith, says Wiley was never in the mine and simply "got even" because he was discharged.

#### GREAT PRODUCING MINE

Persons in position to know say the Potosi mine is in better condition than ever, and will soon be worked on a larger scale. From 65 to 70 men are now employed, and the force will be increased. Arrangements have been made to install expensive machinery, a concentrator, air compressor and electric power from Las Vegas. This will enable the Potosi to produce 100 tons per day, which will be concentrated for economy in shipping.

#### GREAT ORE DEPOSIT

### ARTESIAN WATER

Flows from Pipe Four Feet Above Ground



A good flow of artesian water was struck Thursday morning in the well, two miles northwest of Las Vegas. Many interested citizens visited the derrick and were delighted to witness water flowing from the twelve inch pipe, four feet above ground. The water was struck at a depth of 176 feet, in limestone. Drilling continues at the rate of twelve feet per day, and the contractors expect to break into a river of water any day.

### Ore from the Grand Gulch mine in Large Copper Vein Runs Over \$100.00 per Ton

Near St Thomas, 38 miles northeast of Moapa the Cedar Basin Copper Company has a great deposit of rich copper ore. The vein is four feet wide and the ore is taken out through a drift. Hauling from the mine to Moapa is \$22.00 per ton, and freight by rail to Salt Lake, with Smelter charges, increase the costs of handling to a high figure.

It is estimated that this ore averages from \$90 to \$100 per ton in copper. These figures are sufficient to make a Greenwater man turn green with envy, yet we hear very little of Cedar Basin, Lincoln County. Verily, great noise and great mines are not always found in the same place.
