

fully the moral conditions of the state. He said that the government had issued over 1,800 licenses for the sale of liquor in the state of Nevada while the state records only showed about 1,100. That in every county probably, with the exception of Nye, there were violations of the liquor law as the result of persons selling it without a license. The most of this was done in the redlight and dance hall districts and was a notorious fact. Also that the gaming laws were "winked at" and in several counties the sheriffs and other officers were taken into partnership with the gamblers and the license "arranged."
