


# **Boulder Dam Bill** May Come Before Senate This Month

WASHINGTON, D. C. April 2,-The Republican steering committee of the senate today placed the Boulder Canyon Dam Bill on the legislative program.


The Farm Bill now has the right of way and the discussion of this bill may last for two weeks or longer. Following Farm relief. the Migratory bird measure, which has already been before the senate but was displaced by more important legislation, will be given a few days after which the Boulder dam legislation will have the right of way.

It is estimated that the Boulder dam measure may become the order of business some time between April 12 and 20. There has been no agreement between Arizona and California and none seems probable at this time.

Arizona promises to make a vigorus fight against Boulder dam legislation of any kind. It is impossible to predict the outcome but in the opinion of observers there is a chance for the bill to pass the senate.

STEWART USING PROFESSIONAL CLOAK TO COVER NEFARIOUS PRACTICE IT IS ALLEGED

Presumably hiding under the false and illegal cloak of a practicing chiropractor, A. L. Stewart was arrested last night by Sheriff Sam Gay and lodged in the county jail under a charge of assualt with intent to commit rape upon the person of Christina Ramirez.

The arrest was the outgrowth of claims brought by Mrs. Ramirez before C. D. Breeze, justice of the peace, who issued the warrant. It is alleged that Stewart attempted to force illicit relations with the young woman who was in his office as a patient.

Stewart's bond was placed at \$1000. He had not furnished that amount last night.

The "chiropractor's" trail extends from Needles to Las Vegas, where he had recently been conducting a nefarious practice upon his women patients.

Advices to Sheriff Gay from Needles indicate that Stewart was ordered to leave town by a citizens' committee. He has bad debts in that city totalling well over two hundred dollars.

Instances were cited wherein Stewart had been entangled with various Harvey house women employees and at one time had been severly battered by a railroad man who learned of Stewart's advances to the railroader's wife.

It is believed that the jailed chiropractors had a criminal record extending even before the Needles chapter of his crime ca-Stewart practiced in the reer.
