DELEGATION GOES HOME FROM COL. CONFERENCE

Nevada, Colorado and California said they regretted such slight had been made but were under the impression Arizona's previous stand that she did not care to participate in such matters because of that state's stand as to the validity of the Swing-Johnson bill.

Arizona's three commissioners spoke regarding the incident and Charles B. Ward, Arizonian, read a long news dispatch which he said "implied Arizona had refused to participate in the conference, when in reality Arizona never had been invited."

SANTA FE, Feb. 21. (AP)—The fight over the waters of the Gila River broke out anew in the Tri-State Colorado River Conference yesterday, and with it came the suggestion that preceding a tri-state pact between Arizona, Nevada and California there should be a five-state pact between those three states and Utah and New Mexico to settle the question of allocation of waters of independent streams of the Colorado Basin.

The five state pact which was suggested by Arizona would affect the Gila River, which flows in Arizona and New Mexico, the Little Colorado River and Virgin River whose origin is in Utah.

Exemption of Gila Sought. Arguments over division of water between the lower basin states went on, with Arizona insisting upon exemption of the Gila River for all purposes while California argued for its inclusion, and then both states maintaining their claims for an extra million acre feet.
