

### Lumberjack to Ride the Falls

TWIN FALLS, Idaho, July 8 (AP)—A Washington lumberjack will ride over the great Shoshone falls in a boat, a feat which has never before been attempted.

A contract to attempt the hazardous undertaking on Sunday July 23, has been signed with Al Fausset of Harlow, Washington, by the American Legion.

Fausset has ridden over eight major waterfalls and rapids in the Northwest, including Silver Falls, Ore., 134 feet; Snoqualmie Falls, Wash., 185 feet; and Sunset Falls, Ore., 193 feet. Two broken ribs in the most serious injury Fausset has sustained.

The contract provides that the risk be made in his own boat and Fausset assumes all risks of every kind in connection with the feat. His decision to sign the contract came after a thorough study of the

RENO, Nev., July 8 (AP)—The revenue from the \$25,000 estate of Henry Wood, well known Nevada who died recently in California will be presented to the orphan wards of the Carson City state home as a Christmas present annually.

Wood's will bequeathing the estate's revenue to the orphanage was bitterly contested by relatives. They based their suit on the grounds that for the state of Nevada to control such a fund would cause the government of the state to participate in a religious holiday, which, they contended, was in violation of federal laws.
