Periodically he abandons New York and sets out on an aimless journey about the country, riding in a Pullman stateroom one day and a boxcar the next, searching for new ideas.

A few years ago he was in Milwaukee on one of these random pilgrimages.

As he wandered down the street at midday he encountered a girl, playing there in a touring musical comedy, whom he had known well on Broadway. He was glad to see an old friend, and asked her to have dinner with him that evening at the Pfister. She said she'd love to.

An hour later it occurred to him that he was broke. He felt for something he could pawn and recalled that he had hocked his watch at Joliet and his rings in Duluth. He spent his last half dollar for a seat in a vaudeville house. As he sat carelessly looking at the program it occurred to him that the skit which occupied the stage at the moment was hackneyed and filled with worn jests.

"I wonder," he mused, "how much that fellow would give me for a new skit?"

He went backstage to see. The vaudevillian admitted that he and his missus needed a new act.

"I'll write you one," said the playwright, "and I'll sell it to you cheap for cash."

"You write it," answered the actor, "and if it's any good I'll pay you cash."

Money To Spare
The playwright returned to his room in a cheap hotel and dug out the portable typewriter which was the only possession he never pawned.

He hammered away for two hours and finally folded and put in his pocket ten freshly written pages.

He hastened to the hotel where the vaudeville actor and his wife were staying. The actor was in. He perused the sketch twice, chuckling as he read.

Finally he said: "I like it. How much do you want for it?"

"Twenty-five dollars cash," said the playwright. He got his money and hastened away to prepare for his dinner engagement.

It was a good sketch that he'd written. For three years the vaudeville pair has been tramping in it from coast to coast.

The playwright, shaven and short, sat in the hotel lobby waiting for his girl friend. Six o'clock and she didn't show up. Six-thirty, 7, 7:30—no sign of her. She wouldn't be there now—she was due at the theatre at 8.

It was on Broadway, six months later, that the playwright encountered her again.

"I'm vexed at you," he said. "You broke a dinner date with me in Milwaukee."

"Why!" she exclaimed, "I forgot it, and didn't remember until this minute."

Peach Cream for Dessert

Tomato Rarebit on Toast

Candied Sweet Potatoes

6 medium sized peeled potatoes

1 teaspoon salt

1 cup dark brown sugar

2 cups water

3 tablespoons butter

Lay the potatoes in a baking pan and sprinkle with the salt. Boil the rest of the ingredients 4 minutes and pour over the potatoes. Bake for 1 hour in a moderate oven.

Peach Cream, a Gelatin Dessert

2 tablespoons granulated gelatin

4 tablespoons cold water

1 cup orange juice

1 cup sugar

1 teaspoon vanilla

2 cups whipped cream

2 cups sliced canned or fresh peaches

Soak the gelatin and cold water for 5 minutes. Dissolve over a pan of hot water. Add the orange juice, sugar and vanilla. Allow to cool and thicken a little. Beat until fluffy and beat in the remaining ingredients. Pour into a mold, which has been rinsed out of cold water. Chill until stiff.

Tomato Rarebit on Toast, Serving 6

(Using canned tomato soup)

2 tablespoons butter

3 tablespoons flour

1 cup canned tomato soup

1-2 cup water

2 eggs, well beaten

1-2 cup finely cut cheese

1-4 teaspoon dry mustard

1-4 teaspoon salt

Melt the butter in a frying pan, add the flour, and when mixed add the tomato soup and cook for 1 minute. Add the rest of the ingredients and cook slowly and stir constantly until the cheese has melted. Pour over toast which has been placed on a warm platter.

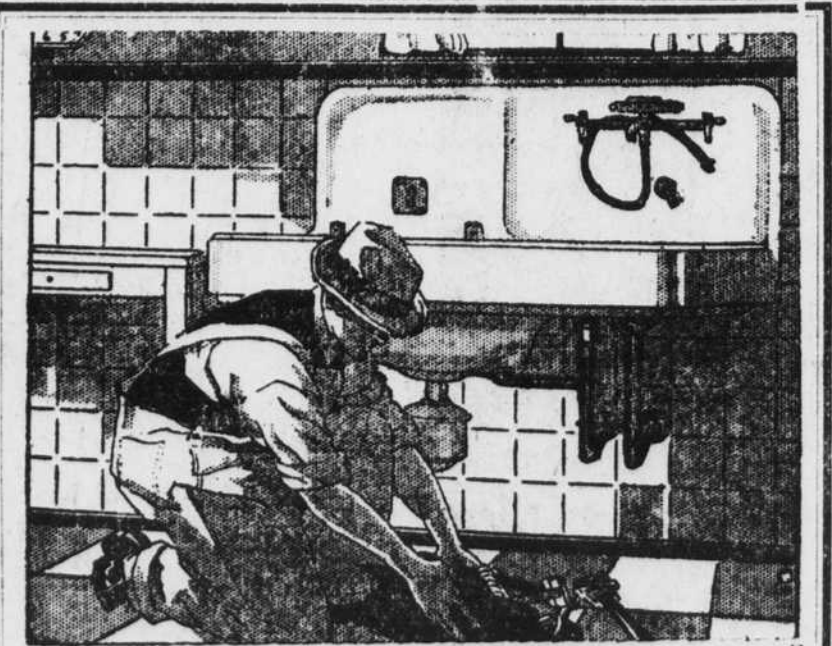

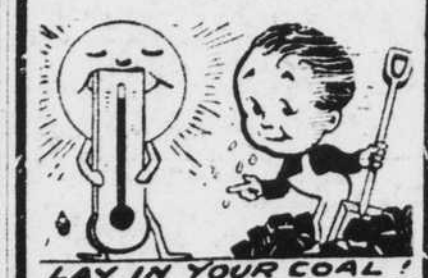
