

President Hoover was pictured in those early days of his presidency as determined not to trespass upon congressional functions in legislative matters; never to attemp; "big stick" methods to force through his own legislative program, or to block

disapproved projects. He was represented as being unalterably opposed to a presidential role as legislative dictator. That attitude has been translated by opponents in congress, both Democrats and those within his own party, into a charge of lack of leader-

ship. What Mr. Hoover now may feel about his theory of dealing with congress, after two years' experience with a congress controllable only by virtue of the large Republican majority in the house, he has never indicated.


