
Foshay Enters Plea of 'Not Guilty'; Trial June 1st

WASHINGTON, March 4. (P-Interior department officials from Secretary Wilbur down awaited with keen interest tonight the arrival of bids upon the gigantic Hoover dam, pewer house and works at Boulder canyon, prepared to speed up awarding of the contract. The bids, opened at the Denver reclamation office, are expected

to arrive Saturday and the contract probably will be let early next week so no time will be lost in starting the work.

Commissioner Mead of the reclamation bureau. Chief Engineer R. F. Walter at Denver and officials of the department were setting in motion the machinery for pushing along the big task confronting them.

The magnitude of the project, Secretary Wilbur said was exmplified in the fact that the contract for constructing it will be the largest ever let by the government and will call for huge quantities of steel, stone and cement to be supplied by the government. He viewed it as the greatest peace time engineering feat.

The Six Companies, Inc., an organization with headquarters at San Francisco formed by six construction agencies combining forces stood out as the probable builder, as their low bid of \$48,890.995.50 was \$5,000,000 below their nearest competitor and within \$200,000 of federal estimates.
