Rochester Co-Ed Wins Her 'R' By Household Tasks

ROCHESTER, N. Y., April 8. (AP)—When a University of Rochester co-ed gets a big "R" insignia for her sweater, it means she is active in extra-curricular work—of almost any description. Until recently awards were granted co-eds only upon completion of competition in athletics. But now a big "R" may be won by wheeling the neighbor's baby carriage, washing dishes or the family car—or even by darning socks. Extension of the definition of extra-curricular activities was voted by the council of the Women's college athletic association because of a dearth of interest in sports. Not more than 10 or 12 women had earned "R"s in athletics during any of the last six years, and the women decided such a state of affairs needed a remedy. As a result, as long as co-eds darn socks belonging to somebody else, wash dishes at their own or perform any of a hundred and one household or other duties aside from fulfillment of personal needs, the tasks may be construed as extra-curricular activities.
