

WORK IS BEING PUSHED FAST IN HOOVER DAM AREA

(Continued from Page One) the transmission line from the substation to Boulder City. Bids on this work were opened May 15 and the work is to be completed within 30 days.

Levis Construction Company is pushing the work of grading for the railroad from Boulder City to the dam site. They are working two shifts a day. Tunnel No. 1 on this work is practically completed its full 230 feet. Tunnel No. 2 is in 164 feet of its total 280 feet. No. 3 has its pioneer tunnel through the full 415 feet and the full tunnel section is in 110 feet. Tunnel No. 4 has the pioneer tunnel through 130 feet of its 165 foot total length.

PUSHING ROAD
R. G. LeTourneau company is pushing the work on the government highway from Boulder City to the dam site. The work of grading has progressed over a mile. They are about to start work on "Branch C," which will lead to the top of Lookout hill.

TELEGRAPH FIRM PLANS NEW BONUS

CLEVELAND, Ohio, May 25. (AP)—An "incentive bonus" described as a measure of the award to the fifteen thousand salaried employees for their contribution to the gross receipts and the operating efficiency of the Postal Telegraph company was announced today by Sathenes Behn, chairman of the board of the International Telegraph and Telephone company, Postal's parent concern.

The plan announced in connection with national sales meeting of fifty Postal Telegraph executives, will be effective June 1 and gradually will be extended to the other 80,000 employees of I. T. & T. and its subsidiaries, Behn said. Characterized as the first plan of its kind adopted by a public service company, it will provide monthly bonuses to all Postal employees excepting messengers and those employed on a piecework basis. Behn said the plan was adopted to stimulate individual incentive among employees.

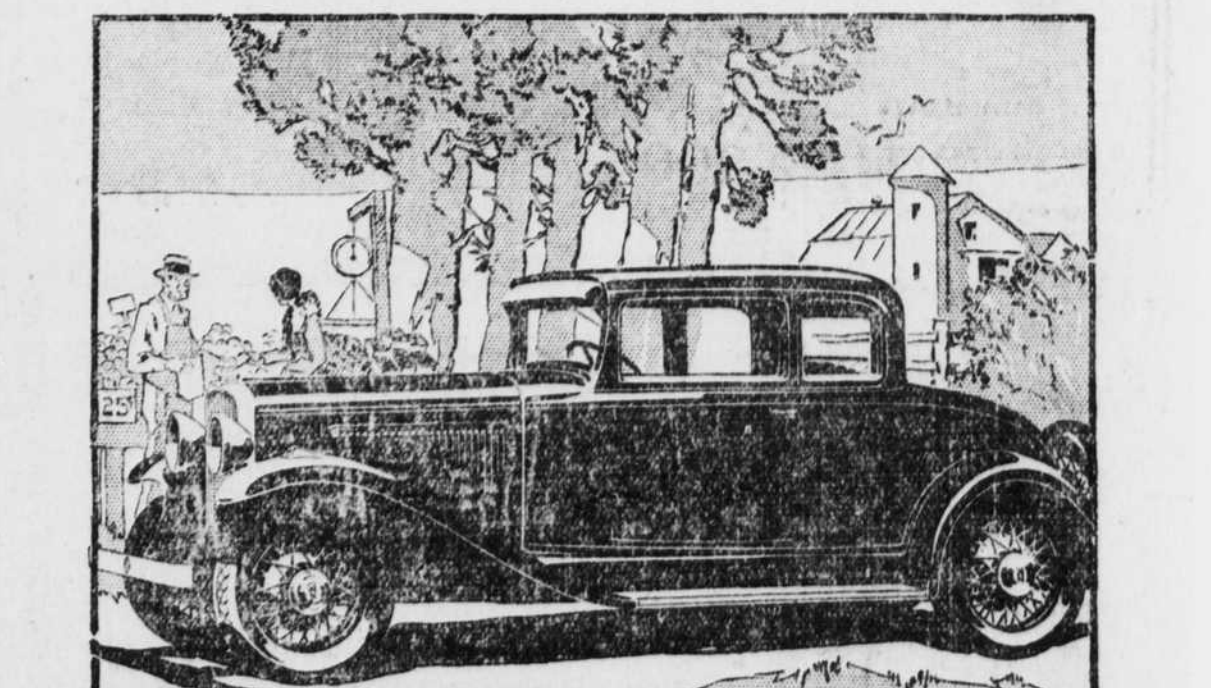
