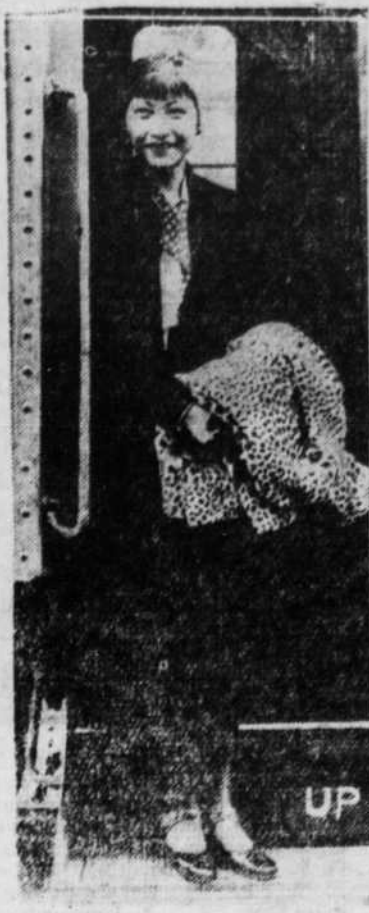


HERE 50 YEARS; ARE DEPORTED
